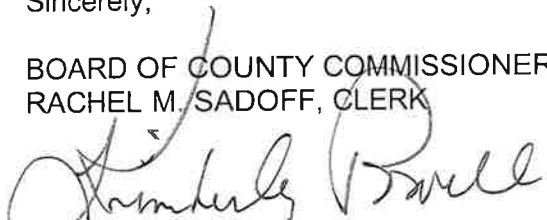
Re: Appointment to Central Brevard Parks and Recreation Advisory Board
