Summary Explanation and Background:

Comments from the public, if any, must precede actions to accept or amend the budget for County agencies, Charter Officers and Dependent Special Districts as summarized: County agencies of \$1,908,672,808, Charter Officers of \$227,094,739, and Dependent Special Districts of \$115,158,328. The total Tentatively approved County Operating and Capital Budget for FY 2024-2025 is \$2,250,925,875.
