 BREVARD COUNTY BOARD OF COUNTY COMMISSIONERS

SUBJECT:	Public Hearing Re: Wickham Road at Forest Lake Avenue / Golden Eagle Court Intersection Improvements Construction Project – District 4 (Fiscal Impact: \$546,000)
DEPT/OFFICE:	Public Works Department / Road and Bridge Construction

Requested Action:
 It is requested that the Board of County Commissioners consider finding it in the public interest for the Brevard County Public Works Department (Road and Bridge Construction) to perform the work for the construction of the Wickham Road at Forest Lake Avenue / Golden Eagle Court Intersection Improvements. Furthermore it is requested that Road and Bridge Construction utilize existing term contracts for the signalization portion of this project. It is also requested that the Board approve any necessary budget change requests.

Summary Explanation & Background:

On August 25, 2016, Brevard County Purchasing Services advertised Bid No. B-3-16-94 Wickham Road at Forest Lake Avenue / Golden Eagle Court Intersection Improvements. Bids were received and opened on September 23, 2016 from two vendors: Gibbs & Register, Inc. and American Lighting and Signalization, Inc. Gibbs & Register, Inc. did not provide the Florida Department of Transportation prequalification, indicating certification in traffic control systems. Furthermore, both bids greatly exceeded the engineer's construction estimate for the project of \$557,164.50.

On October 18, 2016, the Board of County Commissioners granted permission to reject all bids received in response to Bid No. B-3-16-94. Furthermore, the Board authorized staff to advertise for a public hearing to have County staff perform the construction. Based on the Road and Bridge Construction estimate of \$546,000, County staff can perform the work at a potential savings of \$11,000 compared to the engineer's estimate and \$506,351 less than the recent bid amount of \$1,052,351. Road and Bridge Construction has sufficient staff and resources to construct the improvements and will utilize local term sub-contractors and suppliers.

Florida Statute 255.20, Section 9 requires the Board conduct a public hearing for projects built by a County workforce for an amount over \$300,000. The public notice must be advertised at least 21 days prior to the date of the public hearing. The public notice was published on October 20, 2016 in the Florida Today newspaper.

Fiscal Impact: FY 2016/2017 \$546,000 from Constitutional Gas Tax 1170/265410 and Local Option Gas Tax 1163/265160.

As provided in Chapter 255.20 F.S., notice is hereby given that the Board of County Commissioners will hold a public hearing at 9:00 a.m. on November 15, 2016, at the Brevard County Government Center Board Room, Building C, 2725 Judge Fran Jamieson Way, Viera, Florida. The purpose of the hearing will be to consider whether it is in the public interest for the County to perform the construction services for the Wickham Road at Forest Lake Avenue/Golden Eagle Court Intersection Improvements, utilizing County forces and equipment. The project consists of improvement of the existing intersection of Wickham Road, a Brevard County right-of-way, and Forest Lake Avenue / Golden Eagle Court, Brevard County rights-of-way. The proposed improvements include signalization and associated ITS improvements, roadway modifications, and signing and pavement marking within the intersection. The most recent estimated construction cost for the project is \$519,914.77. All those for or against this item may be heard at this public hearing before final action is taken.

Pursuant to Chapter 286.0105 F.S., if any person decides to appeal any decision made by the Board, Agency or Commission with respect to the item stated above, he or she will need a record of the proceedings, and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is based.

Persons seeking to preserve a verbatim transcript of the record meeting must make those arrangements at their own expense.

The needs of the hearing or visually impaired persons shall be met if the department sponsoring the meeting/hearing is contacted at least 48 hours prior to the public hearing by any person wishing assistance.
