PLEASE READ - IMPORTANT INFORMATION

All Violation of Probation charges/arraignment and hearing dates shall be scheduled with the Judge or Division based on **the first letter of the defendant's last name.**

DO NOT SET THE COURT DATE BASED ON THE JUDGE WHO SIGNED THE WARRANT.

These hearing dates should be set on the next available VOP docket for each respective division if the date is **at least 10 days** from the date the warrant is served. If not, then the next VOP docket date should be used for that division.
