It is recommended that the Board assign the task of reading into the record the percentage by which the aggregate millage necessary to fund the tentative budget for FY 2016-2017 is changed from the aggregate rolled back rate.

Aggregate Rolled Back Rate	6.6109 mills
Aggregate Tentative Rate	6.5919 mills
Percentage Change	-0.29% (including voted millages)

Aggregate Tentative Millage From the Aggregate Rolled Back Rate

The Board of County Commissioners, in special session on September 13, 2016, acknowledged the reading into the record the percentage by which the aggregate millage that is necessary to fund the tentative budget for Fiscal Year 2016-2017 is changed from the aggregate rolled back rate of 6.6109 mills, aggregate tentative rate 6.5919 mills, and percentage change of -0.29 percent, including voted millages which the tentative rate represents a 2.81 percent reduction from the current Fiscal Year rate.
