

Renewal of SCADA Support Continuing Consultant Services Contract

This renewal is made and entered into as of the date of the last signature below, by and between BREVARD COUNTY, FLORIDA, a political subdivision of the State of Florida (hereinafter referred to as "County"), and Jacobs Engineering Group, Inc., an entity authorized to do business in the State of Florida (hereinafter referred to as "Contractor").

Witnesseth:

WHEREAS, the County previously entered into an agreement with the Contractor, executed November 15, 2022, under Contract Number 9977, for SCADA Support Continuing Consultant Services (hereinafter referred to as "Original Contract"), which is incorporated herein by this reference; and

WHEREAS, the initial term of the Original Contract is three (3) years from its date of award, and, at the County's sole discretion, the Original Contract may be renewed for two (2) additional one (1) year periods beyond the initial term of the Original Contract by providing prior written notice to the Contractor; and

WHEREAS, the initial term ends on November 14, 2025, and the parties hereto desire to renew the term of the Original Contract for the first of up to two (2) additional one (1) year periods ;

NOW, THEREFORE, in consideration of the premises and mutual covenants contained herein, the parties agree as follows:

1. The above recitals are true and correct and are incorporated into this Renewal by this reference.
2. Notice is hereby given to the Contractor by the County that the Original Contract is hereby renewed pursuant to the notification provision set forth therein for the first of up to two (2) additional one (1) year periods , continuing through November 14, 2026.
3. All terms and conditions of the Original Contract, together with any amendments or modifications thereto, which are incorporated herein by this reference, and which are not inconsistent with the provisions of this Renewal, shall remain in full force and effect.
