**AGENDA REPORT**  
**BREVARD COUNTY BOARD OF COUNTY COMMISSIONERS**

SUBJECT:	Renewal of existing maintenance agreement with Replay
DEPT/OFFICE:	Emergency Management – E911 Administration/Address Assignment

**Requested Action:**

Approval to renew existing Agreement from October 12, 2016 to October 11, 2017.

**Summary Explanation & Background:**

The E911 Administration/Address Assignment division maintains a digital voice recording system utilized by all eleven County and municipal Public Safety Answering Points to record 911 calls. This item requests renewal of the existing maintenance agreement with Replay to service the items of equipment related to the hardware of the 911 system and to maintain the software of the digital voice logging system in good operating condition.

The term of this Agreement, per Replay, was for a period of one year, commencing on 10/12/15 and terminating on 10/11/16, and automatically renewing on the same terms and conditions, on an annual basis, for successive one year terms unless either party notified the other in writing of its intention not to renew at least thirty (30) days prior to the expiration of a Term. However, the Brevard County Board of County Commissioners elected to opt-out of the automatic annual renewal, and approved a one-year agreement. This is the first renewal, for the term of one year, beginning October 12, 2016 and terminating on October 11, 2017. All terms and conditions remain in effect.

All County and municipal Public Safety Answering Points also utilize this system to record law enforcement, fire and medical 800 MHz radio traffic. The costs of 800 MHz radio recording are borne by the Sheriff's Office, County Fire-Rescue, and municipal police & fire departments.

The costs of 911 recording are borne by the Emergency Management department, and funded through State 911 fees. There is no General Fund impact.

**Pricing Breakdown:**

- \$80,852.10 = Yearly Contract Amount
- \$23,504.36 = Cost for Radio Recording
- \$57,347.74 = Balance for 911 Administration (Voice Recording)




