**AGENDA REPORT**  
**BREVARD COUNTY BOARD OF COUNTY COMMISSIONERS**

SUBJECT:	Public Hearing Re: Lake Washington Road at Washingtonia Drive Drainage Improvements Construction Project – District 4 (Fiscal Impact: \$454,954)
DEPT/OFFICE:	Natural Resources Management (NRM) Department / Stormwater and Public Works / Road and Bridge Construction

Requested Action:

It is requested that the Board of County Commissioners consider finding it in the public interest for the Brevard County Public Works Department (Road and Bridge Construction) to perform the work for the construction of the Lake Washington Road at Washingtonia Drive Drainage Improvements. It is also requested that the Board approve any necessary budget change requests.

Summary Explanation & Background:

The Upper Eau Gallie Stormwater Master Plan was designed to reduce flooding, improve water quality, and attenuate peak discharges from the watershed. Most of the Master Plan components were constructed in 2008-2010, however work on I-95 at the same time interfered with completing the drainage improvements at one intersection and conflicts with a natural gas line took time to resolve. This remaining work will replace twin 72-inch culvert pipes with a 6'X14' box culvert. This improvement will decrease flood stages and durations without increasing the volume of water discharged to Lake Washington. An 8-acre stormwater treatment pond and diversion weirs previously constructed on Lake Washington Road remove sediment and reduce pollutants. It is estimated that construction costs will be \$454,954.

The Brevard County Road and Bridge Construction has a proven track record for success with large box culvert projects (Fortenberry Regional Stormwater Management System at \$286,351 (52%) less than engineering cost estimate, Wickham Road at Aurora Stormwater Improvements at \$222,695 (23%) less than engineering cost estimate, and Palm Bay Road Culvert Maintenance, etc.). Given some unique scheduling constraints and utility relocation and avoidance complexities, the experience and efficiency of the Brevard County Road and Bridge Construction is the preferred approach to safely deliver this project on time and within budget. Road and Bridge Construction has sufficient staff and resources to construct the improvements and will utilize local term sub-contractors and suppliers.

Florida Statute 255.20, Section 9 requires the Board conduct a public hearing for projects built by a County workforce for an amount over \$300,000. The public notice must be advertised at least 21 days prior to the date of the public hearing. The public notice was published on November 14, 2016 in the Florida Today newspaper.
