Requested Action:
 IT IS RECOMMENDED THAT THE BOARD APPROVE THE REVISED PRECINCT BOUNDARIES DUE TO COURT ORDERED REDISTRICTING, PRECINCT CONSOLIDATIONS, ANNEXATIONS BY THE CITIES OF WEST MELBOURNE, COCOA, MELBOURNE, AND TITUSVILLE, AND THE ADDITION OF THE VIERA STEWARDSHIP DISTRICT

Summary Explanation & Background:
 These precinct boundary changes are primarily due to the Florida Supreme Court ordered redistricting of the US Congressional and Florida Senate district boundaries. Additional precinct boundary changes are also included due to municipal annexations by the cities of West Melbourne, Cocoa, Melbourne and Titusville, the addition of the Viera Stewardship District, and precinct consolidation.

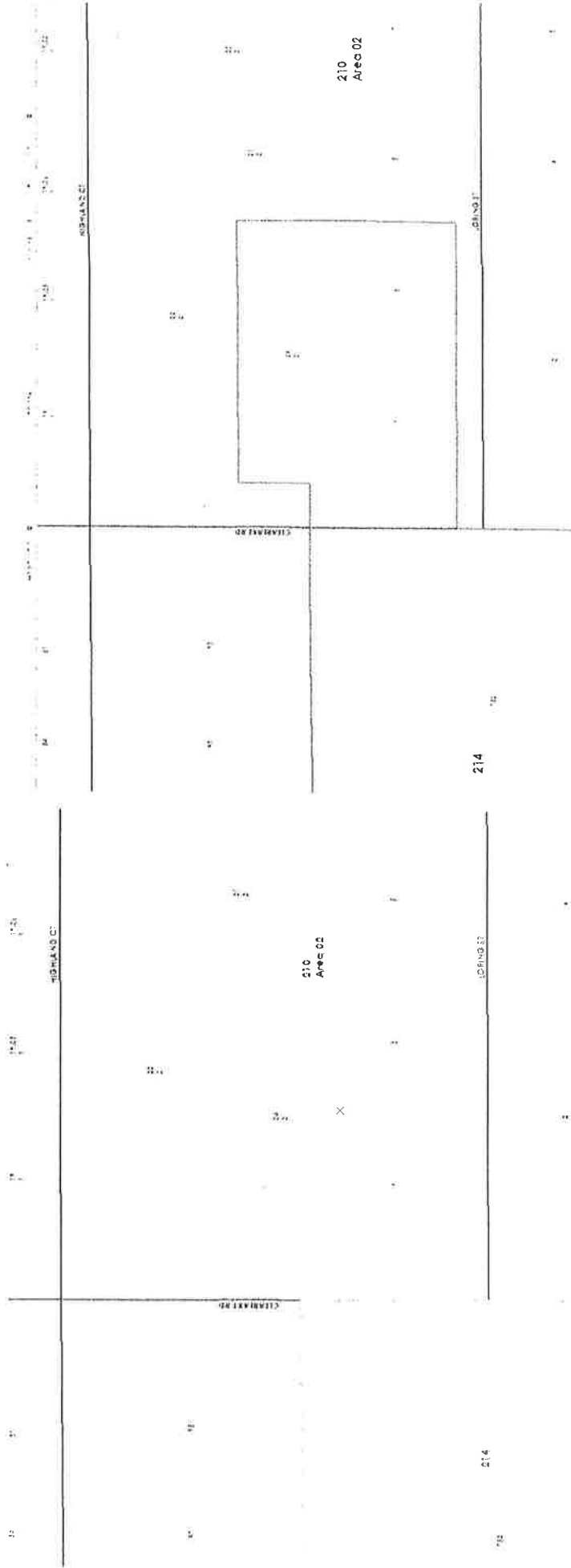
