ORDER RE: STATUS CONFERENCE ON APRIL 8, 2014

THIS CAUSE came before the Court on April 8, 2014, at approximately 5:45 P.M., after the jury's advisory verdict of the death penalty was issued in the subject case. Based on representations made by the parties' attorneys, it is **ORDERED:**

1. On April 8, 2014, the Court ordered the transcripts of the guilt and penalty phases in this case, which were digitally recorded. The Eighteenth Judicial Circuit's Digital Recording Office has prepared the disks with the digital recordings of the guilt and penalty phases in this case, and those disks are ready as of today's date for delivery by the Digital Recording Office to the court reporter designated by the parties. As the parties' attorneys (State and Public Defender's Office) are both requesting transcription for preparation of their respective sentencing memorandums, both the State and the Public Defender's



Office shall equally share the cost of transcription from their respective office's budgets. The parties must notify the Eighteenth Judicial Circuit's Digital Recording Office via e-mail at michael.kazoroski@flcourts18.org **no later than Friday, April 11, 2014, by 5:00 P.M.** as to which court reporter the parties have agreed to use for this transcription. The State and Public Defender's Offices are responsible for instructing the designated court reporter how to bill them. The transcripts of the guilt and penalty phases of the trial shall be provided by the court reporter to counsel by **5:00 P.M. on May 23, 2014.**

2. A Spencer¹ hearing is scheduled for **June 5, 2014, at 2:00 P.M.** before the undersigned judge in Courtroom 4A at the Moore Justice Center, Viera, Brevard County, Florida.

3. The Defendant waived a pre-sentence investigation in this case.

4. Counsel shall file and provide courtesy copies of sentencing memorandums to the undersigned judge **by 5:00 P.M. on June 18, 2014.**

5. Sentencing is scheduled for **June 27, 2014, at 1:30 P.M.** before the undersigned judge in Courtroom 4A at the Moore Justice Center, Viera, Brevard County, Florida.


