Needelman: Ellis' "Complicated" Requests Delayed Release of Clerk Documents, BlueWare Contracts

BREVARD COUNTY, Florida - Last week, Brevard County Clerk of Courts Mitch Needelman announced the award of a five-year, \$8.52 million contract with BlueGem, LLC for digitizing of all past, current, and future Clerk's office records, including many that are currently stored in a former gymnasium in Titusville. The release of the contract to the media has raised new questions from Scott Ellis, Needelman's opponent in this year's primary race.

Ellis had requested a copy of the contract in late May through a <u>public</u> records request. However, news outlets were given copies before Ellis. Some have questioned Needelman's motives about this release.

Needelman says that it is partially timing and partially Ellis' fault since he issues requests in a complicated way.

"The reason Scott did not receive his request back in May was because it was made during contract negotiations, which is protected under statute until completed $^{\mathcal{C}}$. The contract was signed on 06/29/12 and that is the date we released the information. Scott was notified that his request was ready and of his costs on 07/02/12. He didn't pay and pick up until the 3rd."

"Because his real purpose is not to gather information, but to set up failure if possible, his requests are always multi-layered and complicated. His hope is that something will be missed, left out, or simply not accessible without a

"After repeated accusations that what he receives is "not right" I have finally implemented a policy that requires a check-off cover sheet that must be $\frac{\text{completed}}{\text{completed}}^{\text{C}} \text{ before his request is released. This, of course, adds time to the process. I have people dedicated to his searches alone. We had to put something in place to avoid the redundancy he incorporates into every request to try to reduce the workload," Needelman added.$

Ellis has also questioned how this contract will be paid for in these tight budgetary times.

Needelman said, "As far as the funding for this five-year project goes, the sources of revenue will come from the various areas that the scanning impacts. We will evaluate the impact from the various function areas that need scanning and proportion the costs appropriately to each area."

Ellis disagrees with Needelman's claims. "The Clerk's Office is about a \$21 million annual operation. A near \$2 million annual expense for five years is huge. If the Office had \$1.7 million per year just floating around in excess monies (savings) we'd have seen those monies returned to the funding agencies, the State of Florida and the Brevard County Commission. Since only \$100,000 was returned to the State of Florida, with the County simply repaid the \$100,000 in penalties from breaking the <code>insurance</code> contract, clearly more money must come from somewhere to fund this effort."

The contract had previously come under scrutiny from Ellis and he had accused the current Clerk's office of a rigged bidding system and favoritism. Ellis had charged that the bid was only open for seven days through an Invitation-to-Negotiate process. He also claimed that an associate of Needelman had profited financially through this contract award and that Needelman had refused to comply with requests because that fact might be revealed.

Ellis said, "My belief is the current strategy of starving operations to award no -bid and sham-bid contracts to companies represented by Friends of Mitch (FoM) will be expanded.

"The $\underline{\text{public records}}^{\mathcal{C}}$ I have requested have been stonewalled for over a month and are quite simple:

- (i) invoices for monies already paid Blueware;
- (ii) contracts with individuals (such as Tallahassee attorneys and Public Relations spokesmen); and
- (iii) the bids returned from companies on the imaging contract.

"With the award, the contract itself now becomes <u>public record</u>". I believe the invoices will show well over \$500,000 was paid the parent company while the Invitation to Negotiate (ITN) (had) yet to determine the selectee. Needelman has refused for over a month to even identify the name of the firm selected for the negotiations."

Records show the following timeline for the bidding process:

- 5/3 -- An ITN was issued by the Clerk's Office for the digitizing contract.
- 5/7 Questions from bidders were due to the Clerk's Office.
- 5/11 Responses to the questions were due back from the Clerk's Office.
- 5/23 The Clerk's Office selected BlueGem, provided a \$500,000 contract guaranty payment to BlueGem, and began final contract negotiations.
- 6/29 The contract was signed by BlueGem representative Rose Harr and Needelman. Copies were released to the media.
- 7/2 Scott Ellis is notified that requested copies are available.
- 7/3 Scott Ellis acknowledges receipt of a copy of the contract.

According to the contract, "BlueGem will provide a totally functional system providing for the digitization of Brevard County current and historical documents per Florida statutes."

The contract also note that a 90-day pilot project will be initiated called the "Digital Pen Solution Implementation." According to the contract, "The Digital Pen Solution allows instantaneous capture of written data."

The contract notes a pricing schedule that extends payments from the Clerk's Office over the next five years.

May 2012: \$500,000 contract guaranty payment

June 29, 2012: \$50,000 contract signing payment

July 1, 2012 – November 1, 2012: \$250,000 total (5 $\underline{\text{monthiy payments}}^{\text{C}}$ of \$40,000)

December 1, 2012 – November 1, 2013: \$1,440,000 total (12 $\frac{monthly}{payments}$ of \$120,000)

December 1, 2013 – May 1, 2015: \$2,610,000 total (18 $\underline{\text{monthly payments}}^{\text{C}}$ of \$145,000)

June 1, 2015 – May 1, 2017: \$3,720,000 total (24 $\underline{\text{monthly payments}}^{\mathcal{L}}$ of \$155,000)



Charles Parker: Divergent Views on Clerk's Contract Continue

Within a 20-minute timespan on Monday, I received two emails whose contrast could not be starker.

The subject of both is the controversial contract between the Clerk's office and BlueGem Technologies to digitize court records. The contract has been under scrutiny since its signing during the summer.

Clerk of Courts-In-Waiting Scott Ellis sent out a missive that he entitled "Clerk Loots \$6.1 Million for Blueware: Hewlett Packard Left Holding the Bag." In it, he once again calls the BlueGem digitizing contract a "scam" and claims that Hewlett Packard has loaned money to the Clerk's Office to pay-off the

Shortly after, Clerk of Courts-In-Limbo Mitch Needelman issued a press release that begins, "On Friday, December 07, 2012, a milestone event took place in Brevard County that will change the way the Clerk of Courts does business from now into the future."

The English teacher in me cries out, "...two roads diverged in a yellow wood..."

The contract has raised questions many questions. I am still waiting for the answer to a few of them: Who is working, how much are they being paid, what property/equipment was bought, and what are the contract

I have asked the Clerk's Office, BlueWare/BlueGem, Matt DuPree, the Economic Development Commission, all five county commissioners, and the Melbourne Regional Chamber of Commerce.

None have answered. However, I think I already know the answer. These basic criteria – present in most government contracts – are not written down anywhere.

The contract is basically this: Here's the money. We don't care how you get the job done or how you spend the money, you have to get the job done by 2017. Oh – and if you don't – we're covered by insurance that we paid for. So really - we don't care whether you get the job done or not.

And evidently the terms of the contract have changed from the original one signed this summer.

Needelman contracts with BlueWare. Needelman realizes Ellis will cancel the contract and tries to sell it. HP lends money to Needelman – who in turn gives some of the money to BlueWare, buys an insurance bond, and evidently purchases bowling balls (what else does Brunswick Corporation do?).

Also, in October BlueWare chief Rose Harr is given a cushy spot on the Brevard Workforce Board of Directors and then in November is given \$760,000 by the same board for job training.

In this scenario, Ellis assumes the motive of Needelman – to keep Ellis from stopping payments to BlueWare and cancelling the contract when he takes office in January 2013.

But there is a problem with assuming the motive: there is no proof. I am sure if Needelman did not write down contract terms and deliverables, he did not write down the terms of a nefarious plot.

As well, I am sure Needleman would say his motive to change the terms of the contract - which went from \$8.5 million to \$6.1 million - was solely to save taxpayers' money.

Ellis claims, "Clerks cannot enter into promissory notes and borrow money. Legal opinions will be forthcoming when I get into office." At the same time, I would be shocked if Needelman didn't have attorneys who gave him the "okay."

And so the beat goes on. Taxpayer money is being spent on a noble project, but the taxpayers don't really know whether their money is being spent legally and efficiently. For government projects, both should be the standard.

Former Clerk's Digitizing Contract Under More Scrutiny

TITUSVILLE, Florida - Documents released by the new Brevard County Clerk of Courts reveal a complicated payment arrangement between former Clerk Mitch Needelman and BlueWare, Inc. They also raise questions as to what a \$6.1 million is being used for.

New Clerk Scott Ellis has maintained since the summer of 2012 that the digitizing contract between Needelman and BlueWare is a "sham."

A promissory note – a copy of which was released to Brevard Times by Ellis – was signed on October 23, 2012 and indicates that the clerk's office would receive the funds from Hewlett-Packard Financial Services Company for "essential" equipment.

The note states specifically that "the use of the equipment is essential for Maker's proper, efficient and economic operation, Maker will be the only entity to own, use or operate the Equipment during the term of this note and Maker will use the Equipment only for Maker's governmental purposes."

A legal opinion written by Joe Teague Caruso, legal counsel for the clerk's office, also notes, "The Equipment is personal property and will not become a fixture."

Neither the note nor the legal opinion indicates specifically what the "equipment" is.

Then, on October 24, 2012, Needelman requested that the money be directed to three "vendors," each receiving differing amounts: Blue Gem - \$5,690,526; Brunswick Companies - \$209,474; and The Hanover Insurance Company - \$200,000. A second identical payment direction was signed on October 29, 2012.

Hewlett-Packard accepted the promissory note on October 27, 2012.

To further complicate the arrangement, there is disagreement between the documents as to exactly what it should be called.

The promissory note calls the agreement both an "advance" and a "lease." The payment direction letter calls it a "loan." And the clerk's legal representative calls it a "lease."

Deputy Clerk Tyler Winik told Ellis in email communication on January 15 that he is continuing to investigate the relationships between Blue Gem,

Brunswick, and Hanover.



Ellis was cheered by about 200 in attendance, many Clerk employees, after he was sworn in by Brevard County Circuit Court Judge Jack Griesaum. It appears that many employees brought their leftover New Year's Eve noise makers to the ceremony.

Exhibit O 05-2013-CF-064037-AXXX-XX "We will go back to making more information available online for free, saving both the public and the Clerk's Office time and money," Ellis told Brevard Times before today's ceremony. "Turning off many of the contracts signed by the current regime will save well over \$1 million annually.

"More regular workers will be added in place of the excess management and bogus contracts being paid. They will cost less than what is being subtracted, and we have to make it work as currently the office is being overspent through the long term contracts and the hiring of over 30 people after the election.

"I expect our overall staffing levels to be roughly the same. We may have a few more employees who do the work, but the few additional employees will be a saving over the excess management now leaving the building."

One of those contracts – the contentious court records digitizing contract with BlueWare, Inc. – is a focal point of Ellis' changes.

"The Clerk (outgoing clerk Needleman) unlawfully borrowed \$6.1 million from Hewlett Packard and fronted Blueware \$5.7 million for their five year contract. The \$8.3 million for digitizing will be over, unfortunately with more than \$1 million already gone down the drain," Ellis said.

Ellis noted that many of the upper level management are resigning, but there are still salary issues to be considered.

Details of Brevard Clerk of the Court Lawsuits Against BlueGem and RoseWare Emerge In Court Filings

VIERA. Florida – Brevard County Clerk of Court Scott Ellis filed two lawsuits on March 29 to call into question business relationships entered into by former Brevard County Clerk of Court Mitch Needelman regarding a disputed court document scanning deal that has been under scrutiny since last year.

Ellis is also asking the Circuit Court of the 18th Judicial Circuit to force BlueGem LLC and RoseWare LLC to return all sums paid by the Clerk of Court, plus interest and costs. The contracts are worth nearly \$6.5 million. Copies of both filings are posted at the end of this report.

Ellis said immediately after the filing, "We do not believe we received anywhere near promised deliverables on the RoseWare contracts (2013 – CA -33453). We do not believe the BlueGem scanning contract was legitimately bid nor awarded for anywhere near a reasonable price (2013 – CA – 33457)."

The suit regarding the BlueGem contract alleges that Needelman used a bidding, selection, and negotiation process that was "fundamentally flawed and against public policy because BlueGem was intricately involved in the preparation of the ITN (Invitation-to-Negotiate) itself and essentially drafted the same." It claims that BlueGem was responding to questions from other competing vendors prior through the clerk's office.

It also alleges that "former Clerk of Court's executive staff" used private email accounts to communicate "in an attempt to evade and frustrate the disclosure of such communications."

The BlueGem suit also claims what Ellis has been contending for months that the Clerk of the Court cannot borrow money "for the purposes of funding, in whole or in part, its contractual obligations." Needleman changed the terms of the contract in October 2012 – paying BlueGem in full and signing a promissory note with Hewlett-Packard Financial Services. HP has recently threatened to sue Ellis to recoup its \$6.1 million loan - of which Ellis has not been paying the monthly obligation.


Counts 1 and 3 of the RoseWare suit claim that RoseWare breached an information technology consulting services contract signed by Needelman on April 6, 2012 by not meeting deliverables included in the contract. Ellis claims that Needelman paid RoseWare \$250,350.00 before any services were Exhibit P Filmg 7651630. The suit seeks return of those funds, plus interest and costs_{05-2013-CF-064037-AXXX-XX}

Exhibit P

Count 2 claims that RoseWare breached an April 6, 2012 cost containment contract with Needelman. In this agreement, RoseWare was to renegotiate service and supplier contracts of the Clerk's Office and receive 35% of savings or cost reduction. Ellis claims "the Clerk of Court suffered damages."

Finally Count 4 demands a declaratory judgment that "provisions within the Contracts (named in the suit) are void and unenforceable, and/or the Contracts in their entireties are void, and ordering RoseWare to return to the Clerk of Court all sums paid by the Clerk of Court to RoseWare pursuant to the I.T. Consultancy Contract, the Addendum and the Cost Containment Contract..."

Media requests have been sent to representatives of BlueWare, BlueGem and RoseWare. Brevard Times will update this story as more information is gathered.

Brevard Clerk files lawsuit against company lured to Florida with economic incentives

A company that was hailed by Enterprise Florida and Gov. Rick Scott when it decided to move to Florida last year has wasted no time getting into legal trouble.

The company, BlueWare Inc., is being sued by the Brevard County Clerk of Court after a \$8.6 million contract has gone sour.

The company is supposed to digitize millions of pages of records for the clerk's office under a five-year, \$8.6 million contract. But recently elected Clerk of Court Scott Ellis slammed the contract as corrupt and filed a lawsuit last week to recoup millions of dollars.

"The entire bidding, selection and negotiation process regarding the (Invitation to Negotiate) was fundamentally flawed and against public policy because BlueGEM was intricately involved in the preparation of the ITN itself and essentially drafted the same," the lawsuit reads.

Ellis put it more plainly in a recent interview: "It was a sham bid."

Ellis blames his predecessor, who lost a 2012 primary race for reelection, for entering into the poorly written contract and paying BlueWare millions of dollars upfront before the work could be done.

Ellis said BlueWare's vice president was a former business partner with the clerk.

Indeed, an internal memo from the clerk's legal counsel stated: "There may be a civilian insider who will gain a benefit from the awarding of this contract."

According to the lawsuit, two other companies submitted bids for the digitization contract and would have charged less. BlueWare executives were allowed to participate in the selection process and the company was ultimately selected, the lawsuit states.

Executives at BlueWare could not be immediately reached for comment.

The company received incentives awards from the state worth \$1.3 million, including a \$560,000 cash grant for start-up costs. It has not yet received any cash payments.

It's yet another example of an economic incentives project that has led to problems, causing many lawmakers to question if paying companies money to come to Florida is good public policy. Companies like Digital Domain, Banah International and Redpine have all gone bust after getting economic incentives from taxpayers.

Scott hailed BlueWare for relocating from Michigan to Florida last year, saying the company would create 190 high-paying jobs in Melbourne.

"BlueWare's choice to move to Florida is a testament to the strength of our business climate and the result of a common vision for economic growth by local, regional, business and government partners," he said in a statement. "Today's announcement is a great win for the Space Coast, as well as for the entire state."

The company received a contract worth \$760,000 to help train workers last year, but has only used \$1,224, according to the Brevard Times. The Brevard Workforce, which entered the contract, could not immediately provide information about the contract or job creation at BlueWare.

Ellis said the company has not reached its job creation goals and is far behind on digitizing the clerk's records.

BlueWare received more than \$6 million upfront for the five-year project, through a loan agreement between the Clerk of Court and Hewlett Packard last year. After becoming clerk in January, Ellis decided to stop making the payments to Hewlett Packard and filed suit against BlueWare to try and void the contract signed by his predecessor.

UPDATE: BlueWare CEO Turns Herself In

MELBOURNE, Florida – Agents of the Florida Department of Law Enforcement, Office of Executive Investigations, arrested former State Representative and Brevard County Clerk of Court Mitch Needelman, 30, and his one-time business partner, lobbyist William Matthew Dupree, 47.

The two were charged with bid tampering and bribery related to the BlueWare scanning contract signed by Needelman when he was the Brevard County Clerk of the Court. Needelman is also charged with official misconduct for allegedly directing employees to use private

email accounts to circumvent public records laws.

In addition to Needelman and Dupree, an arrest warrant has been issued for BlueWare CEO Rose Harr, 55, also on bid tampering and bribery charges.

The investigation began in July 2012 when FDLE received information alleging Needelman approved Brevard County Clerk of Court contracts with BlueWare in exchange for personal financial gain for himself and Dupree. The investigation focused on a multi-million dollar scanning contract for digitization of Brevard County records even though, at the time, BlueWare had no equipment to scan the documents.

Florida State Attorney Phil Archer said in a release that the investigation revealed that Dupree introduced Needelman to BlueWare CEO Harr and COO Nick Geaney in January 2012.

In March 2012, Needelman and Dupree met with Geaney at Needelman's residence and allegedly told him Brevard County would enter into the scanning contract with BlueWare if a portion of the money paid to BlueWare would be diverted back to Dupree for Needelman's 2012 reelection campaign. According to Archer, the investigation shows that a portion of the BlueWare payments was allegedly funneled back to Dupree for Needelman's 2012 reelection campaign.

In April 2012, BlueWare allegedly assisted in drafting the invitation to negotiate (ITN) for Brevard County Clerk of Court for the scanning contract and subsequently responded to the ITN. The ITN was posted on May 4, 2012, and records indicate questions from other bidders were sent to a county employee's personal email account and then forwarded to Harr and Geaney to write STATE VS NEEDELMAN MITCHELL

responses. The responses were then emailed back to the bidders using the county email system. On May 23, 2012, a payment of \$500,000 was wired to BlueWare even though the contract had not been signed. The actual contract was signed June 29, 2012, and on that day, the first monthly payment of \$90,000 was sent to BlueWare.

In August 2012, Needelman lost his bid for reelection for Brevard County Clerk of Court. Before leaving office, in October 2012, Needelman entered into a loan with Hewlett-Packard Financial Services for \$5.6 million dollars. Information obtained indicated that BlueWare received the loan money although Brevard County was obligated to repay the loan.

Needelman was arrested at his home this morning; Dupree was arrested at his office, 2012 West Drive, Melbourne, Fla. Each was booked into the Brevard County Jail on bonds of \$50,000.

"The investigation shows Needelman, Dupree and Harr swindled Brevard County taxpayers out of millions of dollars," said Florida Department of Law Enforcement Commissioner Gerald Bailey. "Although not the final chapter, today's arrests should present a degree of satisfaction to Brevard County taxpayers."

Brevard County State Attorney Phil Archer's office will prosecute the case. Archer said his office assisted FDLE throughout the probe by subpoening records and data crucial to the case.

"This partnership allows professionals to do the job they are trained to do, free from any outside alliances or influences. It benefits both agencies by allowing prosecutors to attack white collar crime in the courtroom with the facts the law enforcement experts have pursued and established." Archer said.

"FDLE has done an outstanding job on the case," said current Brevard Clerk of Court Scott Ellis who repeatedly raised these allegations during his 2012 campaign to defeat Needelman. "We are mostly just relieved to see these actions brought to justice."

BlueWare Misses Clerk's Office Deadline

MELBOURNE, Florida - BlueWare, Inc., the Brevard County Clerk of Courts digitizing contractor, has missed a deadline to respond to questions from Brevard Times. The Clerk's office had previously said that BlueWare would "be responding in some capacity" by November 7, 2012, according to Katerina Pringis, a Public Records Research Clerk.

In a November 1 email, Jennifer Kenna of BlueWare questioned the relevance of the inquires, but declined to provide clarification, noting that whether or not the company would have further comment "is not my decision to be made." Emails to another BlueWare employee, Kaitlin Welliver, have not been acknowledged by BlueWare. Welliver previously provided on-the-record information.

The follow-up questions were raised after public comment resulting from a October 17 story in Brevard Times about the five-year \$8.5 million digitizing contract between Clerk Mitch Needelman and BlueWare. That story can be linked at http://cpnews.brevardtimes.com/2012/10/court-records-digitizing-underway.html

The outstanding questions include:

- 1. What is the current employment in the BlueGem digitizing effort and how/when will ramp-up occur? Is it true that you are required to hire 192 workers within 24 months to receive Brevard EDC incentives?
- 2. There was a claim that veterans would be hired. How is that process going? Is there a specific system in place to connect your HR with veterans? How many have been hired?
- 3. There are claims that thee has been a high turnover rate in your company as of late. Can you comment on the truth of these claims?
- 4. Where is the new permanent site and what equipment purchase have been made for it?

The questions were also provided to the Economic Development Commission of Florida's Space Coast. Dina Reider-Hicks said that the EDC's role with BlueWare was limited to "business recruitment."

A press release from EDC said, "The EDC worked closely with the company to demonstrate the competitive advantages of locating in Brevard County and developed a competitive proposal outlining the tax advantages and skilled labor pool. BlueWare selected Brevard County over two other potential sites primarily due to its skilled labor pool and attractive tax climate."

Reider-Hicks added, "We have no knowledge or information related to the questions" and "as for the incentives question, BlueWare was awarded performance-based incentives through the state of Florida. You can find details regarding the performance requirements for the incentives on the Enterprise Florida website."

A search of the Enterprise Florida website found no references to "BlueWare," BlueGem" or "Rose Harr." As well, the press link did not have any related stories in 2012.

So evidently this is business as usual for these folks.

When the heat is being put on like it is for them right now no one wants to be associated with a company like this. No colonels, commissioneers or managers are going to even claim they knew them or had anything to do with their relocation.

What I have been told is at one time they were a legit company but their technology grew old and weak and could no longer be competitive. Charles Parker: Divergent Views on Clerk's Contract Continue

Within a 20-minute timespan on Monday, I received two emails whose contrast could not be starker.

The subject of both is the controversial contract between the Clerk's office and BlueGem Technologies to digitize court records. The contract has been under scrutiny since its signing during the summer.

Clerk of Courts-In-Waiting Scott Ellis sent out a missive that he entitled "Clerk Loots \$6.1 Million for Blueware: Hewlett Packard Left Holding the Bag." In it, he once again calls the BlueGem digitizing contract a "scam" and claims that Hewlett Packard has loaned money to the Clerk's Office to pay-off the contract.

Shortly after, Clerk of Courts-In-Limbo Mitch Needelman issued a press release that begins, "On Friday, December 07, 2012, a milestone event took place in Brevard County that will change the way the Clerk of Courts does business from now into the future."

The English teacher in me cries out, "...two roads diverged in a yellow wood..."

The contract has raised questions many questions. I am still waiting for the answer to a few of them: Who is working, how much are they being paid, what property/equipment was bought, and what are the contract

I have asked the Clerk's Office, BlueWare/BlueGem, Matt DuPree, the Economic Development Commission, all five county commissioners, and the Melbourne Regional Chamber of Commerce.

None have answered. However, I think I already know the answer. These basic criteria – present in most government contracts – are not written down anywhere.

The contract is basically this: Here's the money. We don't care how you get thejob done or how you spend the money, you have to get the job done by 2017. Oh – and if you don't – we're covered by insurance that we paid for. So really – we don't care whether you get the job done or not.

And evidently the terms of the contract have changed from the original one signed this summer.

Needelman contracts with BlueWare. Needelman realizes Ellis will cancel the contract and tries to sell it. HP lends money to Needelman – who in turn gives some of the money to BlueWare, buys an insurance bond, and evidently purchases bowling balls (what else does Brunswick Corporation do?).

Also, in October BlueWare chief Rose Harr is given a cushy spot on the Brevard Workforce Board of Directors and then in November is given \$760,000 by the same board for job training.

In this scenario, Ellis assumes the motive of Needelman – to keep Ellis from stopping payments to BlueWare and cancelling the contract when he takes office in January 2013.

But there is a problem with assuming the motive: there is no proof. I am sure if Needelman did not write down contract terms and deliverables, he did not write down the terms of a nefarious plot.

As well, I am sure Needleman would say his motive to change the terms of the contract – which went from \$8.5 million to \$6.1 million - was solely to save taxpayers' money.

Ellis claims, "Clerks cannot enter into promissory notes and borrow money. Legal opinions will be forthcoming when I get into office." At the same time, I would be shocked if Needelman didn't have attorneys who gave him the "okay."

And so the beat goes on. Taxpayer money is being spent on a noble project, but the taxpayers don't really know whether their money is being spent legally and efficiently. For government projects, both should be the standard.

Hewlett Packard Threatens Lawsuit Over BlueWare Debt: Ellis Stands Firm

TITUSVILLE, Florida — Hewlett-Packard Financial Services has warned Brevard County Clerk of the Courts Scott Ellis in a letter from their attorney that they will "file a lawsuit" to recover funds regarding the Clerk's office digitizing contract with BlueWare, Inc.

In the past Ellis has said he would not pay the note. Ellis added on Friday, "I am looking forward to the lawsuit and we shall govern ourselves accordingly!"

In part the letter from Berger Singerman law firm says, "As you know, on October 23, 2012, the Brevard County Clerk of the Circuit Court (the "Clerk") executed Promissory Note number (the "Note") in the amount of \$6,100, 000.00 payable to HPFS representing payment for certain software provided to the Clerk's office, which has been and continues to be used by the Clerk. As you know, no payment has been made to HPFS on this obligation since December 2012 and the Note is now in default. (Another payment of \$110,776.00 is due on March 26, 2013.)

The letter further says that the loan is in arrears of \$332,328.00 and to be current the Clerk's office should pay \$443,104.00 by March 26. (See entire letter below.)

Former Clerk Mitch Needelman originally hired BlueWare in the summer of 2012 with an \$8.5 million contract to scan court documents. Needelman changed the deal in October 2012 by borrowing \$6.1 million from Hewlett-Packard and paying BlueWare in full.

BlueWare has repeatedly refused comment on the scope of work completed so far. They have said that their goal was to have 1.5 million documents scanned by December 2012.
