# HISTORIC BREVARD

Fishing was a popular pastime both for recreation and livelihood, and 'fish stories' abounded. In 1901, after the State Legislature had outlawed the use of seines, Judge Minor S. Jones of Titusville defended a neighbor caught violating the law while fishing for mullet by ruling that the mullet was more closely related to chicken than other fish because it had a gullet. Although the ruling was later overturned, mullet became known as 'Indian River Chicken' for years afterward.
