Re: Brevard County Pretrial Release Annual Report
for Calendar Year 2010

The following report is submitted as statutorily required under Section 907.043, Florida Statutes. Reported information was recovered, researched and recorded manually by accessing data from the Pretrial Release register, Criminal Justice Services automated system (AS400) and the Brevard County Clerk of Courts eFACTS tracking system. The following data is submitted for the reporting period of 01/01/2010 through 12/31/2010.

Requested information and responses:

1. The name, location and funding sources of the pretrial release program, including the amount of public funds, if any, received by the pretrial release program:

The Brevard County Pretrial Release Program is administered by the Brevard County Board of County Commissioners and functions under the direction of the Department of Criminal Justice Services. The program is housed at the Brevard County Jail Complex, located at 860 Camp Rd., Sharpes, FL 32927, phone number: (321) 690-1514.

Program funding is provided by the Brevard County Board of County Commissioners. Operational budget for Fiscal Year 2010 was \$696,985. There was no capital budget for this fiscal year. This program is fully funded through general fund dollars.
