**IN RE: CRIMINAL FIRST APPEARANCE - OPERATION "SAFENET" MARCH 19 THROUGH
23, 2014 IN SEMINOLE COUNTY**

The Seminole County Sheriff's Office, in connection with Florida Department of Law Enforcement and various other Florida Municipal and County Law Enforcement agencies, is conducting an undercover internet operation which will last several days in an attempt to investigate internet crimes and individuals who arrange meetings with minors over the internet to engage in sexual activity. These individuals may travel to Seminole County to an undisclosed location as a result of the investigation and arrests may follow. The investigation will arrange for arrests of certain individuals engaged in this type of criminal activity to occur on the dates mentioned above. There is a concern that a person released on bond could access the internet and electronically post and disseminate information about the ongoing undercover operation over the internet to other individuals. Such actions would reveal the existence of this undercover operation and could endanger the law enforcement officers involved. In order to preserve the integrity of the ongoing investigation, as well as the safety of the law enforcement officers involved in the operation, it is necessary to implement certain conditions of pre-trial release in the form of this administrative order number prior to the operation.


It is hereby **ORDERED AND ADJUDGED** that the following conditions of pre-trial release shall be imposed at first appearance for individuals arrested in connection with Operation "SafeNet,"

1. Any defendant arrested in this operation will be held without bond until appearing in front of a Judge at First Appearance.
2. After First Appearance, Defendant must post bond according to the guidelines of the administrative order 12-05-S. The first appearance judge may adjust the amount of bail as authorized by the Florida Rules of Criminal Procedure. The bond shall be adjusted to the higher amount indicated in the bond schedule if the defendant is an out of county, out of state, or out of country resident.
3. Any defendant arrested in this operation shall have the following bond conditions imposed in addition to any other conditions:

- a. Defendant may not initiate contact with any non-familial child under the age of 18 and may not have intentional contact with any non-familial child under the age of 18 years.
- b. Defendant may not possess or utilize any computers or other electronic devices connected to the internet.
4. The arresting deputy/law enforcement officer shall submit to the Clerk their probable cause affidavits and any other documentation through standardized procedures currently in place. The arresting deputy/law enforcement officer shall indicate that the arrest is in connection with Operation SafeNet and subject to the confidentiality requirements of administrative order number 14-16-S.
5. This order shall not impair any of the Defendant's rights available under the Florida Rules of Criminal Procedure.

It is **FURTHER ORDERED** that this Administrative Order number be sealed until March 24, 2014, in order to preserve the integrity of an ongoing criminal investigation and the safety of the law enforcement officers involved.
