

NEW CHANGE TO BREVARD COUNTY COURT CASES

(Effective January 6, 2025)

All county court cases are now assigned to county judges by the first letter of the defendant's last name.

Select the correct calendar

The first one is for **DUI and Traffic** arraignments.

The second one is for **Misdemeanor** arraignments.

The third one is for **VOP** arraignments.

Please follow these steps to assign the correct court date:

STEP 1: WHAT IS THE FIRST LETTER OF DEFENDANT'S LAST NAME?

STEP 2: WHICH JUDGE HAS THAT LETTER?

STEP 3: FIND THE ARREST DATE AND SELECT THE ARRAIGNMENT COURT DATE.

When setting a court date for the following:

Misdemeanor offenses/Criminal traffic offenses/Municipal or county ordinance violations/Traffic infractions/Violation of probation offenses

based on **the first letter of the defendant's last name.**

- DO NOT SET THE COURT DATE BASED ON THE JUDGE WHO SIGNED THE WARRANT.**
- These hearing dates will be set on the next available VOP docket for each respective division if the date is

at least 10 days from the date the warrant is served.
If not, then the next VOP docket date shall be used for that division.
