Justification:

The purpose of this budget change request is to shift available funding associated with Mosquito Control pesticide chemicals to provide funding for the replacement of a 20-year-old electric impoundment pump that was ordered in FY 2021-2022, but was not delivered until October 2022 (FY 2022-2023). Due to production delays caused by Hurricane Ian, the vendor was unable to deliver the pumpby September 30, 2022. Funding is being shifted from the Chemical Operating Expense to the Capital Outlay to fund this equipment in FY23, and the department intends to replenish the Chemical Operating Expense budget during mid-year supplements when additionalBalance Forward is recognized.

Alternative:

If this Budget Change Request is not approved, insufficient funds will be available to purchase the replacement impoundment pump.
