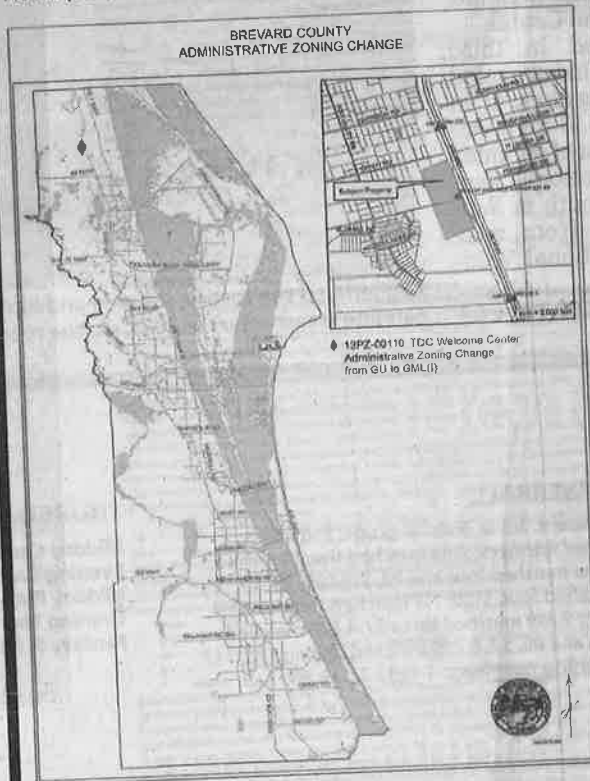

NOTICE is hereby given pursuant to Chapters 125 & 163, FLORIDA STATUTES, and Chapter 62, Article VI of the Brevard County Code, that the Board of County Commissioners will consider the following requests: The Brevard County Board of County Commissioners, pursuant to the provisions of Future Land Use Policy 15.3, Brevard County Comprehensive Plan, as adopted on September 8, 1988, et seq. authorized administrative rezoning, pursuant to Future Land Use Policy 15.3, which states, "Brevard County shall administratively rezone those properties with zoning classifications which are inconsistent with the Future Land Use Map and Density Area Maps". The items to be considered are as follows:

Item III.C.1. on the Planning & Zoning Board Administrative Rezoning Agenda of March 10, 2014, as follows: **DISTRICT 1 III.C.1 (13PZ-00110) Section 22, Township 20G, Range 34, Sub. #A1, Block 7, Lot 1, on 20.57 acres; and Section 35, Township 20, Range 34, Parcel 3, on 18.3 acres, located on the west side of I-95, between Gandy Road and Hidden Lakes (In the Mims area. No assigned address)** CURRENT ZONING: GU (General Use) PROPOSED ZONING: (GML(I)) (Government Managed Lands - Institutional). OWNER: State of Florida (DOT).
