Resolution 19-049

Supporting the Passage of Senate Bill 1738

WHEREAS, Senate Bill 1738, an act relating to animal welfare, has been introduced by Senator Joe Gruters of Dist. 23; and

WHEREAS, dogs, due to their sentience and capability of feeling, perception, and affection, ought to be afforded certain protections not necessarily afforded to non-sentient creatures; and WHEREAS, the legislature has long recognized the need to protect animals from inhumane treatment by virtue of having criminalized cruelty to animals pursuant to §828.12, Fla. Stat.; and WHEREAS, §828.12, Fla. Stat., as presently enacted, criminalizes depriving any animal of necessary sustenance or shelter; and

WHEREAS, hurricanes represent a genuine and persistent threat, year after year, in coastal areas throughout Florida; and

WHEREAS, §828.12, Fla. Stat., ought to be amended to specifically criminalize leaving a dog outside and unattended by use of a restraint during a manmade or natural disaster so that there may be no ambiguity, whatsoever, as to the criminality of this inhumane and cruel action.

NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, does let it be known that it supports the passage of Senate Bill 1738.
