Having been a recipient of BCA funding for many years it is sad that providing Arts and Culture for the citizens of Brevard County is no longer a priority.

→ The fact that our County Commission fails to see the value in the amazing organizations here in Brevard that produce such high-quality performances and events that allow our residents to be culturally enlightened without having to drive out of the county is truly heartbreakng.

There should be a calculation done to estimate the money Brevard residents spend in pursuing cultural entertainment out of our county.

I would urge the County Commission to revisit their true mission of improving the quality of life here in Brevard and reprioritize Arts & Culture for our residents.



Madam:

I am rather surprised by your below message and I hope that it was perhaps meant factiously or sarcastically and that this was simply lost in the written word.

Who am I to take, at penalty of imprisonment, property owners' tax dollars and decide to which organizations I wish to give them? Why your group and not one which helps kids with cancer? Or mental health facilities? Or churches? That should be the decision of the individual taxpayer with respect to their own funds, not the government at the threat of imprisonment for failure to pay.

I will not stop you from donating your own funds to any group you wish. That's your business.

It is not typically the government's place to subsidize, on an ongoing basis, businesses which do not turn a profit. I would hazard a guess that you do not identify as a fiscal (or any other kind of) conservative as your comments are entirely opposed to fiscal conservatism.

Despite my concerns, I was the deciding vote which enabled funding to be authorized and, by way of history, but for me, the BCA would have been utterly cut off from the county's coffers. I also recommended the BCA be given space in the county building in which my office is situated at no cost to them and this was done. Yet your email is disparaging and suggests I do not appropriately value such organizations. No good deed, I suppose...

While I do not intend to hold your entitled and somewhat condescending remarks against any other organization, your remarks reflect upon your employer.

Such messages are highly counterproductive and, push me in a direction opposite yours. Lastly, if you're going to criticize me (oddly enough despite my having supported your desired cause), you could at least spell my name correctly.
