REQUESTED ACTION:

In accordance with Section 62-1157, it is requested that the Board of County Commissioners accept and authorize the Chair to sign the Binding Development Plan.

SUMMARY EXPLANATION and BACKGROUND:

On May 24, 2018, the Board will conduct a Public Hearing to approve Item IV.H., a request for a change of zoning classification from PUD to BU-2, contingent upon a BDP (Binding Development Plan). In an effort to accommodate the developer's construction schedule, the applicant has provided staff a fully-executed BDP for recordation, and requests Board acceptance at the same hearing as the zoning action. If the Board denies Item IV.H., or the applicant volunteers to modify the conditions during the public hearing, there is no need to take action on this BDP acceptance.

The BDP is a voluntary agreement presented by a property owner to self-impose limits upon development of a property in support of a change of zoning or conditional use permit. Pursuant to 62-1157, BDP shall be recorded in the public records within 120 days of approval of the zoning application by the Board.

The limitation in the BDP is consistent with Board action approving the zoning classification change.

- The use of the Property by Developer/Owner shall be limited to the BU-2 use of self-storage mini-warehouses, while retaining, without limitation, all uses, rights, provisions, and activities allowed under the BU-1 zoning classification.

BINDING DEVELOPMENT PLAN

THIS AGREEMENT, entered into this 24 day of May, 2018 between the BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, a political subdivision of the State of Florida (hereinafter referred to as "County") and SCHACHT FAMILY HOLDING COMPANY, LLC, a Florida Limited Liability Company (hereinafter referred to as "Developer/Owner").

RECITALS

WHEREAS, Developer/Owner owns property (hereinafter referred to as the "Property") in Brevard County, Florida, as more particularly described in Exhibit "A" attached hereto and incorporated herein by this reference; and

WHEREAS, Developer/Owner has requested the BU-2 zoning classification(s) and desires to develop the Property as a 3-story, climate controlled self storage facility, and pursuant to the Brevard County Code, Section 62-1157; and

WHEREAS, as part of its plan for development of the Property, Developer/Owner wishes to mitigate negative impact on abutting land owners and affected facilities or services; and

WHEREAS, the County is authorized to regulate development of the Property.

NOW, THEREFORE, the parties agree as follows:

1. The County shall not be required or obligated in any way to construct or maintain or participate in any way in the construction or maintenance of the improvements. It is the intent of the parties that the Developer/Owner, its grantees, successors or assigns in interest or some other association and/or assigns satisfactory to the County shall be responsible for the maintenance of any improvements.

2. The use of the Property by Developer/Owner shall be limited to the BU-2 use of self-storage mini warehouses, while retaining, without limitation, all uses, rights, provisions, and activities allowed under the BU-1 zoning classification.

3. Developer/Owner shall comply with all regulations and ordinances of Brevard County, Florida. This Agreement constitutes Developer's/Owner's agreement to meet additional standards or restrictions in developing the Property. This agreement provides no vested rights against changes to the Comprehensive Plan or land development regulations as they may apply to this Property.

4. Developer/Owner, upon execution of this Agreement, shall pay to the County the cost of recording this Agreement in the Public Records of Brevard County, Florida.

5. This Agreement shall be binding and shall inure to the benefit of the successors or assigns of the parties and shall run with the subject Property unless or until rezoned and be binding upon any person, firm or corporation who may become the successor in interest directly or indirectly to the subject Property, and be subject to the above referenced conditions as approved by the Board of County Commissioners on May 24, 2018. In the event the subject Property is annexed into a municipality and rezoned, this Agreement shall be null and void.

6. Violation of this Agreement will also constitute a violation of the Zoning Classification and this Agreement may be enforced by Sections 1.7 and 62-5, Code of Ordinances of Brevard County, Florida, as may be amended.

7. Conditions precedent. All mandatory conditions set forth in this Agreement mitigate the potential for incompatibility and must be satisfied before Developer/Owner may implement the approved use(s), unless stated otherwise. The failure to timely comply with any mandatory condition is a violation of this Agreement, constitutes a violation of the Zoning Classification and is subject to enforcement action as described in Paragraph 6 above.



Background & Purpose of Request

The applicant is seeking a change of Zoning classification from Planned Unit Development (PUD) to Retail, Warehousing and Wholesale Commercial (BU-2) for the purpose of developing a multi-story mini-warehouse facility. Under the current PUD Zoning classification, this tract can use BU-1 commercial zoning uses, which includes mini-warehouses as a Permitted Use with Conditions, pursuant to Section 62-1837.5. Although this use can be performed under the existing zoning, the conditions stated in Section 62-1837.5 subsection (b) limit the building height to the height of the lowest principle structure on any adjacent parcel.

Under the BU-2 Zoning classification, mini-warehouses remain a Permitted Use with Conditions, but only one specific condition regarding location relevant to the Merritt Island Redevelopment Area is applicable. The height limitation associated with this use within the BU-1 Zoning would no longer apply, if the zoning were changed to BU-2. The applicant also had an opportunity to amend the PUD Zoning by revising the Preliminary Development Plan to allow for BU-2 uses to be conducted at this location, but determined that this was a more costly/length process than directly seeking the BU-2 Zoning classification.

Land Use Compatibility

The subject parcel retains a Development of Regional Impact (DRI) Future Land Use designation. **FLUE Policy 8.1** describes that Brevard County shall adopt a Development of Regional Impact (DRI) land use designation which depicts approved DRIs on the Future Land Use Map. Each DRI shall adhere to the conditions contained within its adopted Development Order as amended from time to time. The approved development amounts for each land use type are listed below for each DRI and may be exceeded by amending the approved Development Order only if the approved changes do not represent a Substantial Deviation pursuant to the requirements of Subparagraph (b) of Subsection (19), Chapter 380.06, Florida Statutes.

The requested BU-2 Zoning classification is consistent with the DRI Future Land Use designation. As this request proposes to rezone from PUD to BU-2, the Board may wish to consider whether design standards should be proposed in order to maintain continuity/compatibility with the adjacent PUD zoned area.

The Board should evaluate the compatibility of this application within the context of the Board's Administrative Policies 1 - 8 of the Future Land Use Element, as outlined on pages 2 through 5 of the Administrative Policies.

Environmental Constraints

Applicable Land Use Policies

The current PUD Zoning classification has been on this property since zoning action number **Z-10249**, dated May 20, 1999. The current tract use defined within the Preliminary Development Plan (PDP) is for BU-1 commercial uses. The property to the south is to be used for multi-family development and the portion to the southwest is for single-family development. The property to the east is designated for commercial BU-1 use. The property lying to the north of Viera Blvd is also zoned PUD and is allowed to develop BU-1 commercial uses.

The parent tract (Tract O, P) totals about 33.3 acres in area and extends westward to the I-95 R-O-W. This zoning action is the latest zoning file maintained in this one-mile section for base zoning changes. Zoning actions for alcoholic beverage CUPs may have occurred more recently, but didn't change the character of the area. Conditional use permit action # **13PZ-00014** was alcohol approval for units 217, 219 & 221 of the Viera East Market Centre (Florida Wine & Spirits) located at the west end of the shopping center. Board approval was granted on May 30, 2013. Another prior alcohol approval was for Long Doggers under CUP action number: **12PZ-00085** approved February 7, 2013.


The subject parcel contains mapped hydric soil (Pompano sand); an indicator that wetlands may be present on the property. Section 62-3694(c)(3)b has allowances for wetland impacts for commercial uses along "Mitigation Qualified Roadways" (MQRs). Viera Boulevard is an MQR in this vicinity. The applicant shall complete High Function and Landscape Level wetlands assessments prior to the allowance of any impacts. Board approval may be required for impacts. Any permitted wetland impacts must meet the requirements of Sections 62-3694(e) and 62-3696. The applicant is encouraged to contact NRM at 321-633-2016 prior to any land clearing activities, plan or permit submittal.

Pompano sand also functions as an aquifer recharge soil. The applicant is hereby notified of the development and impervious restrictions within Conservation Element Policy 10.2 and the Aquifer Protection Ordinance.

Information available to NRM indicates that federally and/or state protected species may be present on the property. 3. Developer/Owner shall comply with all regulations and ordinances of Brevard County, Florida. This Agreement constitutes Developer's/Owner's agreement to meet additional standards or restrictions in developing the Property. This agreement provides no vested rights against changes to the Comprehensive Plan or land development regulations as they may apply to this Property.

4. Developer/Owner, upon execution of this Agreement, shall pay to the County the cost of recording this Agreement in the Public Records of Brevard County, Florida.

5. This Agreement shall be binding and shall inure to the benefit of the successors or assigns of the parties and shall run with the subject Property unless or until rezoned and be binding upon any person, firm or corporation who may become the successor in interest directly or indirectly to the subject Property, and be subject to the above referenced conditions as approved by the Board of County Commissioners on _____ . In the event the subject Property is annexed into a municipality and rezoned, this Agreement shall be null and void.

6. Violation of this Agreement will also constitute a violation of the Zoning Classification and this Agreement may be enforced by Sections 1.7 and 62-5, Code of Ordinances of Brevard County, Florida, as may be amended.

7. Conditions precedent. All mandatory conditions set forth in this Agreement mitigate the potential for incompatibility and must be satisfied before Developer/Owner may implement the approved use(s), unless stated otherwise. The failure to timely comply with any mandatory condition is a violation of this Agreement, constitutes a violation of the Zoning Classification and is subject to enforcement action as described in Paragraph 6 above.



REQUESTED ACTION:

In accordance with Section 62-1157, it is requested that the Board of County Commissioners accept and authorize the Chair to sign the Binding Development Plan.

SUMMARY EXPLANATION and BACKGROUND:

On May 24, 2018, the Board will conduct a Public Hearing to approve Item IV.H., a request for a change of zoning classification from PUD to BU-2, contingent upon a BDP (Binding Development Plan). In an effort to accommodate the developer's construction schedule, the applicant has provided staff a fully-executed BDP for recordation, and requests Board acceptance at the same hearing as the zoning action. If the Board denies Item IV.H., or the applicant volunteers to modify the conditions during the public hearing, there is no need to take action on this BDP acceptance.

The BDP is a voluntary agreement presented by a property owner to self-impose limits upon development of a property in support of a change of zoning or conditional use permit. Pursuant to 62-1157, BDP shall be recorded in the public records within 120 days of approval of the zoning application by the Board.

The limitation in the BDP is consistent with Board action approving the zoning classification change.

- The use of the Property by Developer/Owner shall be limited to the BU-2 use of self-storage mini-warehouses, while retaining, without limitation, all uses, rights, provisions, and activities allowed under the BU-1 zoning classification.
