**SUBJECT:**

Approval: Re: Renewal of Existing Contract with Nabors, Giblin & Nickerson, P.A. for Bond Counsel Services

**FISCAL IMPACT:**

Fiscal Impact: Expenditures for services are contingent upon bonding activity conducted by the County. Expenditures for the last three years are:

- FY 2017/18 \$152,592.60
- FY 2016/17: \$ 57,269.80
- FY 2015/16: \$135,891.59

Current expenditures for FY 19/20 are \$56,579.13.

**REQUESTED ACTION:**

It is requested the Board of County Commissioners approve and authorize the Chairman to execute the final renewal to the Bond Counsel Services Contract with Nabors, Giblin & Nickerson, P.A.

**SUMMARY EXPLANATION and BACKGROUND:**

The County's Bond Counsel, Nabors, Giblin & Nickerson, P.A., provides services to Brevard County in connection with financing, transactions and legal matters relating to the ongoing management of the County's debt.

On July 22, 2015, the Board of County Commissioners executed a three year contract with Nabors, Giblin & Nickerson, P.A. for bond counsel services. The contract includes a provision that the contract may be extended for two one (1) year renewals at the discretion of the Board of County Commissioners.

The current renewal to the contract is for the final renewal with the same terms and conditions remaining in force as the original contract. The new term shall begin July 22, 2019 and continue through July 22, 2020.


