# Requested Action:

It is requested the Board approve the County EMS Advisory Council appointments and reappointments, as per ordinance, to serve on the Council for the two (2) year term beginning on October 1, 2022 and ending on September 30, 2024.

# **Summary Explanation and Background:**

Brevard County Code of Ordinances, Article III, Section 42-88 established the Emergency Medical Services (EMS) Advisory Council (Council) to carry out advisory duties within the realm of emergency medical services as the Board and/or Fire Chief may delegate to the Council from time to time. Representation consists of the County Fire Rescue Chief or designee, one representative from each of the hospital systems located in the County, one representative from each private-based emergency medical educator, one representative from each public-based emergency medical educator, and three (3) representatives from the Space Coast Fire Chiefs' Association (SCFCA), representing the north, central, and south county geographical areas. Council members are appointed for a term of two-years.
