## FIRST AMENDED LIMITATION ON TOURISM AND LODGING ORDER IN ACCORDANCE WITH EXECUTIVE ORDER 20-91 (COVID-19 DOCUMENT #12)

WHEREAS, on March 14, 2020, a State of Local Emergency was declared by Brevard County (Covid-19 Document #1); and

WHEREAS, on March 16, 2020 the First Amendment to the State of Local Emergency Proclamation was issued (COVID-19 Document #2); and

WHEREAS, on March 18, 2020 the Second Amendment to the State of Local Emergency Proclamation was issued to close all beach public parking access in Brevard County (COVID-19 Document #3); and

**WHEREAS**, the COVID-19 virus poses a health threat to Brevard County residents and current visitors, particularly the elderly and others who are medically vulnerable; and

WHEREAS, minimization of contact is necessary to avoid risk of spreading the COVID-19 virus to the residents of and current visitors to, Brevard County; and

WHEREAS, on April 1, 2020, Governor DeSantis issued Executive Order 20-91 wherein he ordered that persons who are 65 years of age or older and persons who have significant underlying medical conditions shall stay at home and take all measures to limit the risk of exposure to COVID-19; and

WHEREAS, in Executive Order 20-91, Governor DeSantis further ordered that all persons in Florida shall limit their movements and personal interactions outside of their home to only those necessary to obtain or provide essential services or conduct essential activities; and

WHEREAS, hotels, motels and other commercial lodging are identified in Executive Order 20-91 as essential services; and

**WHEREAS**, tourism is not identified as an essential service or essential activity in Executive Order 20-91; and

WHEREAS, on March 27, 2020, Governor DeSantis issued Executive Order 20-87 wherein he significantly restricted vacation rentals throughout the State of Florida until further notice; and

WHEREAS, on April 10, 2020, Governor DeSantis issued Executive Order 20-103 wherein he extended the restriction on vacation rentals found in Executive Order 20-87; and

WHEREAS, high travel volumes and mass gatherings create an increased risk of escalating the spread of the COVID-19 virus; and

**WHEREAS**, Maria Stahl, DNP, RN, Administrator for the Florida Department of Health, opined that in her expert opinion that it would help to reduce the rate of infection to restrict travelers from coming to Brevard County; and

WHEREAS, Dr. Stahl was appointed as the Department of Health's (DOH) administrator in Brevard in November 2016 with the concurrence of Brevard County's Board of Commissioners, and Dr. Stahl has worked 37 years in public health practice including 13 years in public health practice in Buffalo, New York; and

**WHEREAS,** Dr. Tai F. Yang, a pediatrician in Brevard County, Florida contacted Brevard County Emergency Management to request the reduced exposure of patients to the virus by reducing the number of tourists in the County; and

WHEREAS, according to a recent study of counties above 500,000 people throughout the country, Brevard County, as well as several other central Florida counties, were among those that had the highest average travel through March 27, 2020

WHEREAS, Brevard County intends to fully comply with Governor DeSantis' Executive Order 20-91 and take action locally to ensure that the people in Florida are staying home except for the limited purpose of obtaining or providing essential services or conducting essential activities; and

**WHEREAS**, per Dr. Stahl, acceleration of the number of cases of COVID-19 in the neighboring counties increases the risk that individuals in those counties may inadvertently bring the virus to Brevard County; and

**WHEREAS**, limiting the number of people entering Brevard County, Florida may reduce the rate of exposure to the COVID-19 virus within the County

WHEREAS, the Policy Group adopted the Order limiting Tourism on April 2, 2020, and

WHEREAS, the Board of County Commissioners requested that the Policy Group revisit the Order and provide a self-certification procedure, and

WHEREAS, since the adoption of the Limitation on Tourism and Lodging Order, various requests for changes and clarifications have been received, and

ENFORCEMENT OF EXECUTIVE ORDER NO. 20-91 ISSUED BY GOVERNOR RON DESANTIS ON APRIL 1, 2020; TOURISM AS A NON-ESSENTIAL ACTIVITY AND CLOSURE OF BREVARD COUNTY TO TOURISTS; HOTEL AND CAMPGROUND DIRECTIVES AND ORDERS TO LIMIT NON ESSENTIAL ACTIVITY AND ALLOW SPECIFIED ESSENTIAL SERVICE SUPPORT SERVICES: In order to protect the residents of Brevard County Florida from the ongoing public health threat posed by the COVID-19 pandemic and follow the guidelines regarding the "Safer at Home" Order, Executive Order 20-91, and in recognition of the limited definition of essential activities, therein, Brevard County finds tourism and general leisure activities related to tourism are not authorized under Executive Order 20-91. - I. Persons sheltering in place or living in Brevard County, Florida on April 1, 2020 pursuant to Executive Order 20-91 who need to continue sheltering in Brevard County, Florida.
- J. Persons who are authorized medical or health care providers requiring sheltering in place or living in Brevard County, Florida on April 1, 2020 pursuant to Executive Order 20-91, to provide bonafide health or medical care assistance to the citizens of Brevard County.

The Board of County Commissioners asked the Policy Group to revisit the Limitation on Tourism to allow domestic violence victims to check into hotels without a note from a doctor or employer. The BCC asked the Policy Group to create a self-certification procedure for lodgers with third degree felony consequences for a violation. At the Policy Group meeting, the Sheriff asked for time to have his attorney review the proposed change and the City of Cocoa Beach's City Manager also requested time to consult with his attorney. Both attorneys responded to emails and phone calls within hours. Their professionalism, efficiency, cooperation and courtesy is greatly appreciated. The attached document has been reviewed, edited and approved by both those attorneys. We went back to the original Order and provided track changes so you can see the alterations to what is already in place in the simplest format. A short summary of what was changed from the original order follows:

- On the face of the Order, domestic violence victims were added as authorized lodgers; however, they had to be living in Brevard County or sheltering in Brevard County as of April 1, 2020, the date of the Executive Order from the Governor requiring Floridians to shelter at home.
- 2. Instead of providing for self-certification and removing the employer's letter or doctor's note provisions, the Sheriff and Cocoa Beach suggested <u>adding</u> the self-certification procedure so that all three options are available to lodgers. That change is on the face of the Order.

3. On Attachment B of the Order there is a self-certification form similar to the state form submitted to the BCC earlier this week. It also contains a signed statement from the lodger. Although perjury and third degree felony provisions were proposed, the Sheriff and Cocoa Beach requested that the perjury sections be removed. Accordingly, the document merely refers to a second degree misdemeanor.

If the Group would prefer to use the perjury and third degree felony provisions, the following language could be inserted.

I declare, under penalty of perjury under the laws of the United States of America that I have read this document and to the best of my knowledge and belief, the facts stated above are true and correct. I understand that a violation of Brevard County's Limitation on Tourism and Lodging Order is a second-degree misdemeanor pursuant to section 252.50, Florida Statutes. Additionally, I understand that if I knowingly making a false written declaration herein, I could be found guilty of the crime of perjury by false written declaration, a felony of the third degree, punishable as provided in section 775.082, 775.083, or 775.084, Florida Statutes. This certification is executed on the date written below.

4. The list of authorized lodgers (Attachment A to the revised Order) lists the users or lodgers described specifically in the order and addresses several types of users mentioned by the community. Because the Executive Order describes hotels and essential businesses and numerous other businesses and activities as essential, there are areas which have created questions for the hoteliers. These items are highlighted because they were not discussed by the Board of County Commissioners. These users, or lodgers, are restricted to individuals who were in Brevard County on April 1, 2020 when the Executive Order was issued by the Governor. With the restriction, the Sheriff and Cocoa Beach find the listings acceptable.

Please let me know your comments. I believe Items 3 and 4 will be your areas of concern.
