**STEP 3: FIND THE ARREST DATE AND SELECT THE ARRAIGNMENT COURT DATE.**

- Criminal traffic offense
- Municipal or county ordinance violations
  - Traffic infractions
- Violation of probation offenses

### PLEASE READ - IMPORTANT INFORMATION

All Violation of Probation charges/arraignment and hearing dates shall be scheduled with the Judge or Division based on **the first letter of the defendant's last name.**

- 1) **DO NOT SET THE COURT DATE BASED ON THE JUDGE WHO SIGNED THE WARRANT.**
- 2) These hearing dates will be set on the next available VOP docket for each respective division if the date is **at least 10 days** from the date the warrant is served.  
If not, then the next VOP docket date shall be used for that division.
