WHEREAS, Brevard County is home to more than sixty-five thousand veterans and fortyeight hundred veteran-owned firms per the U.S. Census Bureau, 2012 Economic Census: Survey of Business Owners; and

WHEREAS, there are 87,756 veteran-owned businesses in Florida generating \$57.7 billion in annual sales; and

WHEREAS, less than one-half of one percent of the US population served our Country in the Armed Forces, yet veteran-owned businesses represent nine percent of all US firms (2017 SBA); and

WHEREAS, the Florida Association of Veteran Owned Business, Space Coast has over 100 veteran-owned business and patriotic supporter (non-veteran) businesses as members; and

WHEREAS, the Florida Association of Veteran Owned Businesses is a non-profit entity that advocates, educates and connects our veteran-owned businesses to economic opportunity; and

WHEREAS, the Florida Association of Veteran Owned Businesses (FAVOB) and the Small Business Administration (SBA) have entered into a Strategic Alliance Memorandum as of October 2020; and

WHEREAS, National VETERAN SMALL BUSINESS WEEK is dedicated to supporting veteran entrepreneurs and business owners and their families, and to encourage people to purchase goods and services from these hard-working men and women; and

WHEREAS, Florida veterans and their families deserve our unwavering support and gratitude.
