SUBJECT:	Public Hearing; RE: Wickham Park Pedway Construction - District 4 There is no fiscal impact as a result of this action.
DEPT/OFFICE:	Community Services Group / Parks and Recreation Department Development and Public Services / Public Works Department

Requested Action:
It is requested the Board of County Commissioners consider approval for the Brevard County Public Works Department (Road & Bridge Program) to perform the services necessary for the construction of the pedway at Wickham Park.

Summary Explanation & Background:

In regular session, on April 19, 2016 the Board authorized advertisement of a Public Hearing to be held regarding Road & Bridge performing the services necessary for the construction of the pedway at Wickham Park.

Both the design and cost estimating have been completed and all regulatory permits have been received. Based on the Engineer of Record and the Brevard County Public Works Department, construction cost estimates for the pedway, Public Works (Road & Bridge) can perform the services at a cost of \$459,943 which is a savings of \$46,057.

If the services could not be performed by Road & Bridge, it would impose additional expenses and time delays. The Road & Bridge Program has sufficient staff and resources to construct this pedway and will utilize local sub-contractors and suppliers for the project.

Florida Statutes 255.20, Section 9 requires the Board to conduct a public hearing for projects being built by a County work force for an amount over \$300,000 and a public notice must be advertised at least 21 days prior to the date of the public meeting. The posting requirement was successfully completed on April 19, 2016.
