Requested Action:

It is requested the Board of County Commissioners initiate a resolution opposing "All Aboard Florida's" choice of Siemens to run its' trains.

Summary Explanation & Background:

Siemens chosen by "All Aboard Florida" to run its trains, rewards one of the worst German Nazi companies in the Holocaust responsible for slave labor and gas chambers costing hundreds of thousands of lives; including at Auschwitz, Buchenwald, Ravensbrueck, and 400 other sights.

There is also recent corruption exposés. Siemens offered \$12 million to Holocaust survivors while earning \$104 Billion annually. This is the tip of the Siemens horror I wish to address.
