Requested Action:

It is requested that the Board of County Commissioners consider the adoption of a resolution creating the South/Central Brevard Parks and Recreation Advisory Board, consolidating the Cocoa West Recreation Complex Advisory Committee, the Central Area Merritt Island/Beaches Recreation Advisory Board, and the Parks and Recreation Department South Area Advisory Board ("Three Parks and Recreation Boards") into the newly created South/Central Brevard Parks and Recreation Advisory Board, and rescinding resolutions 19-236, 19-071, 15-106, and 95-72.

Summary Explanation and Background:

The Three Parks and Recreation Boards all exist in the southern and central parts of Brevard County. The new Resolution would create a new South/Central Brevard Parks and Recreation Advisory Board and consolidate the Three Parks and Recreation Boards into the newly created South/Central Brevard Parks and Recreation Advisory Board. This consolidation would increase efficiency and facilitate communication by combining the Three Parks and Recreation Boards into one regional parks and recreation advisory board. The Resolution contains provisions on the membership, terms of appointments, meeting frequency, and use of County staff time for the new South/Central Brevard Parks and Recreation Advisory Board.
