WHEREAS, the leadership of the coaching staff, dedication of volunteers and the commitment shown by every skater, on and off the ice, brings a great deal of pride to our County.

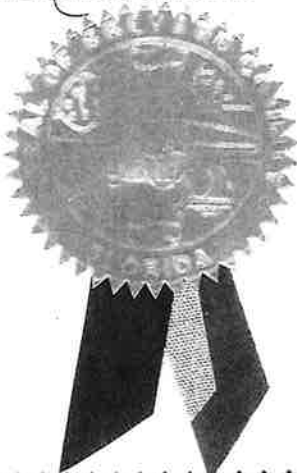
