Approval of Authorizing Resolution, Grant Application, Use of Toll Revenue Credits, Execution of Follow Up Grant Agreement, Re: FY 2019 Space Coast Area Transit Bus and Bus Facilities Grant (Section 5339) from Federal Transit Administration (D2)

\$322,641 in Federal Transit Administration grant funds

REQUESTED ACTION:

It is requested that the Board of County Commissioners approve the following actions for a FY2019 Section 5339 Bus and Bus Facilities Grant from the Federal Transit Administration (FTA) in the amount of \$322,641:

- the Chair to sign the Authorizing Resolution,
- the Chair to sign the Grant Application,
- the use of the Florida Department of Transportation (FDOT) Toll Revenue Credits,
- the Chair to sign the Designation of Signature authority allowing staff to submit the Grant electronically,
- the Transit Director to execute and submit the Grant Agreement electronically, contingent upon County Attorney and Risk Management approval,
- the Transit Director to execute any additional follow-up documentation/resolutions and amendments necessary to secure these funds.
- authorize the County Manager to approve all necessary Budget Change Requests

SUMMARY EXPLANATION and BACKGROUND:

Space Coast Area Transit is in the process of demolitioning the condemned building on King Street, located to the North Terminal on Varr Avenue in Cocoa. The plans are to create additional parking for employees and transit vehicles to make room to build a bus passenger Transfer Center on Varr Avenue. Space Coast Area Transit has received Federal funding for the demolition of the building and construction of the Transfer Center.

The initial plans were to use gravel on the parking area, however, any employee parking

must meet ADA requirements, therefore civil design, construction and amenities will need to be added to this project. All these costs were not included in the previously approved FTA grants.

Under the Moving Ahead for Progress in the 21st Century Authorization, Section 5339 Bus and Bus Facilities funding is a formula program that is allocated to urbanized areas. Space Coast Area Transit has a balance of \$322,641 from FY 2016 apportionment that has not been applied to a grant application. Space Coast Area Transit proposes to use these funds to complete the construction of the parking area.

The local match for the capital projects will be provided through the Florida DOT Toll Revenue Credits Policy. Under this program, no exchange of funds occurs, however, the use of the Transportation Development Credits will allow for 100% Federal participation in SCAT's FY 2019 capital projects.

The Grant Application and Program of Projects will be submitted to the Federal Transit Administration for their review and the grant will be added to the Transit Services FY 2018-2019 Budget.

RESOLUTION authorizing the filing of application(s) with the Department of Transportation, United States of America, for grant(s) under the Urban Mass Transportation Act of 1964, as amended.

WHEREAS, the Secretary of Transportation is authorized to make grants for a mass transportation program of projects and budgets; and

WHEREAS, the contract for financial assistance will impose certain obligations upon the applicant, including the provision by it of the local share of the project costs in the program; and

WHEREAS, it is required by the U. S. Department of Transportation in accord with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance under the Urban Mass Transportation Act of 1964, as amended, the applicant gives an assurance that it will comply with Title VI of the Civil Rights Act of 1964 and the U. S. Department of Transportation requirements thereunder; and

WHEREAS, it is the goal of the applicant that minority business enterprise be utilized to the fullest extent possible in connection with these project(s), and that definite procedures shall be established and administered to ensure that minority business shall have the maximum construction contracts, supplies, equipment contracts, or consultant and other services.
