#### Subject:

Approval, Re: Florida Department of Environmental Protection Grant NF120 - Brevard County Parks and Recreation 4 Parks Septic-to-Sewer Projects, District 2

### **Fiscal Impact:**

Grant revenue in the amount of \$750,000. The local match requirement of \$750,000 is met by the FY 21-24 budget of \$1,185,214 for Parks and Recreation Septic-to-Sewer Projects.

#### **Requested Action:**

It is requested that the Board of County Commissioners:

- approve the grant;
- authorize the County Manager to approve and execute the grant contract upon Risk Management and County Attorney approval;
- 3) authorize the Parks and Recreation Director to sign future agreements, amendments, and modifications upon Risk Management and County Attorney approval; and
- 4) authorize the County Manager to execute necessary budget change requests.

## **Summary Explanation and Background:**

The Florida Department of Environmental Protection (DEP) recently notified Brevard County Parks and Recreation of a grant award of \$750,000 to assist in the Parks and Recreation's Septic to Sewer projects in four County parks. The grant award requires a 50% local match that will be provided through existing budgeted project funds. The Florida DEP requires that grant acceptance be completed by October 20, 2023.

The grant will be applied to Septic-to-Sewer Projects at the following Parks:

- Rotary Park Merritt Island, 1899 South Courtney Parkway, Merritt Island
- Manatee Cove Park, 4905 North Tropical Trail, Merritt Island
- Riverwalk: A Family Park, 5355 US Highway 1, Rockledge
- Kelly Park East, 2550 North Banana River Drive, Merritt Island

Congratulations on your grant award. I look forward to working with you as the DEP grant manager.

Funding for Project Title of \$750,000 will be made available through a cost reimbursement grant, which will require execution of a grant agreement with the Department of Environmental Protection. Your community or agency will be considered a Grantee. To draft an agreement, we will need you to provide the following information to us by October 20th, 2023 (the sooner the better for this agreement, we are behind on the info for the grant amount being fully accepted by EPA):

- Agreement Contact Information Authorized Representative (to sign Agreement), Grant Manager (must be employed directly by the Grantee), Disbursement Contact, and Primary contact (if they are not one of the others listed)-on the attached Agreement Contact Information form
- Initiation Document Project Information, Project Background, Project Description, estimated project benefits, Tasks, Budget Amount for each Task, Budget Category, and Task timelines
- Certificate of Insurance Coverage with the Department of Environmental Protection named as an additional insured or a letter from your community or agency's Chief Financial Officer stating that the Grantee is self-insured (see the attachment summarizing the current grant agreement requirements for insurance coverage or self-insurance).
- Location map and/or a site plan, if you would like to have those included in your Grant Work Plan
- The City needs a W-9 on file. Visit <a href="https://vendor.myfloridamarketplace.com/search/vendor">https://vendor.myfloridamarketplace.com/search/vendor</a> for more information.
- FFATA Form Complete the federal funding accountability and transparency act form, required for all federal agreements.

Your project description should indicate if the project will be completed with the funding provided. It should also indicate if this is a continuation of a project for which there is already Grant Agreement in place with the Department, and if so, note the project number.

I will use that information to draft a work plan consistent with requirements of the Department of Financial Services, with deliverables and performance measures. I will prepare the agreement documents for execution by both parties. I will make every effort to send you the agreement soon after we have received your attachments and any additional information needed to complete the documents.
