**Repealing Brevard County Ordinances 58-36 through 58-43; Instituting

Dissolution of Brevard County Historical Commission; providing for adequate services to retain historical documents and data.

Board Issuance of Legislative Intent and Permission to Advertise

SUMMARY EXPLANATION and BACKGROUND:

On December 13, 2018, the Board scheduled a workshop to discuss advisory boards.

On May 16th, 2019 at the start of the workshop, it was abruptly cancelled without discussion. At that time, the District 3 Commissioner distributed certain materials for future consideration and discussion. It was indicated that the suggestions contained in these documents were meant to be a starting point for discussion rather than direct proposals.

While the full advisory board discussion is a necessary one that will be requested to take place at a future meeting, events have transpired which warrant the Historical Commission to be separated and treated independent of that discussion.

As such, it is requested that the Board issue legislative intent and permission to advertise such that the Historical Commission is effectively dissolved and its functions replaced as necessary through other means.
