Requested Action:
It is requested that the Board of County Commissioners approve and authorize the Chairman to execute the attached Resolution proclaiming May 17th to May 23rd, 2015 as "National Public Works Week" in Brevard County.

Summary Explanation & Background:
The American Public Works Association (APWA) actively promotes the various public works functions (road and bridge maintenance, stormwater and utility services, solid waste management, public buildings, and transportation planning and engineering) provided by governmental bodies.
Each year APWA works with agencies at the national, state, and local level to promote these services through the establishment of "NATIONAL PUBLIC WORKS WEEK". This year the week of national recognition is scheduled for May 17th through May 23rd, 2015.
The 2015 National Public Works Week theme, "Community Begins Here," recognizes the essential nature of Public Works services in support of everyday quality of life.

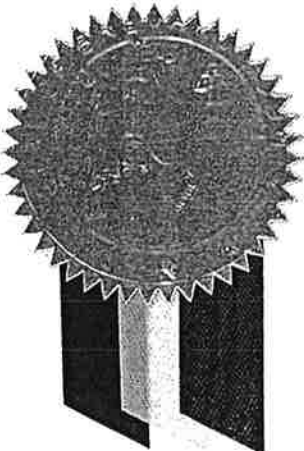
