#### Justification:

The purpose of this Budget Change Request is to shift funding out of reserves and into Grants & Aids for several economic incentive awards that will be paid in Fiscal Year 2021. At the beginning of Fiscal Year 2021, the North Brevard Economic Development Zone awarded incentive payments to Blue Origin and the BBL Florida Hotel Group. The remaining budget in Grants & Aids is no longer sufficient to fund incentive award payments for Lockheed Martin. Lockheed Martin has surpassed key benchmarks that will trigger incentive award payments in the near future and this budget change requests provides enough funding to complete these payments.
