Request that the Board acknowledge the Brevard County Comprehensive Annual Financial Report (CAFR) for the fiscal year ended September 30, 2016

**Summary Explanation & Background:**


The Brevard County Comprehensive Annual Financial Report presents the combined financial position and results of operations of the Board of County Commissioners, Charter Officers and dependent districts. The General Fund financial information in the CAFR of each Charter Officer is combined for presentation with the Board. The individual financial information and audit reports for each Charter Officer will be presented in the Annual Financial Audit report, which is scheduled to be completed by May (required to remit to the State Auditor General's office by June 30, 2017). The financial information as reported in the CAFR is at both the fund level and the government wide level, which can allow users to review for both compliance and the allocation of resources.

The CAFR is prepared in accordance with the generally accepted accounting principles and is commonly used by other government agencies, institutions, investors and the public to obtain financial information on Brevard County. The CAFR information is also available on the Clerk's website at: [www.brevardclerk.us](http://www.brevardclerk.us).

The Management's Discussion and Analysis section (page 4) provides a narrative overview and analysis of the financial activities of Brevard County. Also included in this report is a Statistical Section (page 149) which provides 10 years of historical information and the Single Audit Section (page 173) which identifies Expenditures of Federal Awards and State Financial Assistance.
