Approval; Re: Purchase of Six (6) Stryker Power Load Systems and Stretchers

Fiscal Impact:

\$397,667.78 is identified and accounted for in the department's FY 2024-25 budget.

Dept/Office:

Public Safety Group: Brevard County Fire Rescue (BCFR)

Requested Action:

Request the Board of County Commissioners approve the purchase of six (6) Stryker power load systems and six (6) Stryker stretchers for a total cost of \$397,667.78. Additionally, request the Board to delegate to the County Manager, authority to execute and approve budgetary change requests, administrative actions, or any documents necessary to complete this purchase.

Summary Explanation and Background:

The Stryker Power Load Systems and Stretchers were not included in the original order of six rescue units. BCFR is requesting approval to purchase six power load systems and stretchers. The funds required to purchase these systems are included in the FY 2024-2025 approved Fire Rescue budget for vehicles.

Upon approval and placement of the order, the Department anticipates receipt and installation within six months. These Stryker systems are consistent with those currently in use across all BCFR rescue units and are required to meet operational and safety standards.
