

WHEREAS, Ruby Robinson Clay was born March 17th 1919 in Accoville, a small coal mining town in West Virginia; and

WHEREAS, Ruby quit school at the age of 15 to work fulltime in the garden to help feed the family, then at the age of 18 she began working in a coal mining store where she met her husband Reggie Clay; and

WHEREAS, In 1959, in search of a better life, Ruby and Reggie moved to Indian River City, Florida now known as Titusville where they raised their family; and

WHEREAS, Ruby attended night school at Titusville High School and received her GED at the age of 55, then went on to Brevard Community College where she was inducted into the Honor Society; and

WHEREAS, Ruby became an activist for children who were incarcerated and a Chaplain with the prison ministry at Sharpes; and

WHEREAS, at age 87 Ruby was one of 200 selected to meet with President Bush for the Faith Based Ministries Conference, and at age 90 was awarded the Point of Light Award at the Governor's Mansion in Tallahassee; and

WHEREAS, Ruby has spent her life putting God first and working in the ministry serving those in need.
