It is requested that the Brevard County Board of County Commissioners acknowledge the receipt of the Economic Development Commission of Florida's Space Coast's Bi-Annual Financial Report for their expenditures from October 1, 2021 through September 30, 2022 and the Fiscal Year End 21/22 Economic Development Metrics.

Summary Explanation and Background:

On May 30, 2019, the Board of County Commissioners approved the Grant Agreement between Brevard County and the Economic Development Commission. This Agreement requires the Economic Development Commission to submit a bi-annual report to the County Manager providing the amount of County Grant funds expended to fulfill the requirements in the County's Grant Agreement.

According the agency's bi-annual financial report, the agency has spent \$1,400,050 of the grant funds provided by the County and the prior year net carry forward amount of \$42,628. These funds have been spent in the following categories: Marketing, Communications & Programs, \$90,378; Facilities & Occupancy, \$130,300; General Administration, \$47,703; Personnel, \$1,079,488; Consulting, Accounting, Legal & Research, \$94,809.
