Summary Explanation and Background:

The subject parcel consists of +/- 1.00 acre of vacant property located at 4590 Lime Street, Cocoa, 32926 (Brevard County Property Appraiser Parcel ID #24-35-04-01-25-12, Tax ID 2401734). The parcel escheated to the County in April 2013, and on July 21, 2015, the BOCC approved the parcel be sold by bidding process.

Sales on this parcel were conducted in, 2016, 2017 and, 2018 with a minimum suggested bid of \$35,000 at each offering; no bids were received at any of the offerings. 
