RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, AMENDING RESOLUTION NUMBER 13-229, IN ORDER TO ADOPT THE WATER AND SEWERAGE MAINTENANCE INDEX FOR SETTING ANNUAL INCREASES IN MONTHLY WATER AND SEWER CHARGES IN LIEU OF THE CONSUMER PRICE INDEX (CPI-U); PROVIDING FOR RATIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Brevard County, Florida, hereinafter referred to as the "Board," previously adopted Ordinance Number 13-229; which provided for automatic annual increases in monthly water and sewer rates for the Countywide system effective January 1, 2014 and subsequent years; and

WHEREAS, on February 18, 2021, the Board approved a change to Resolution 13-229 in order to use the Water and Sewerage Maintenance Index in lieu of the Consumer Price Index for future annual increases; and

**WHEREAS**, the Board now desires to amend Resolution No. 13-229 in order to reflect those changes.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, that Resolution Number 13-229 is hereby amended as follows:

## Section 1. Section 4. of Resolution 13-229 is hereby amended as follows:

4. Effective January 1, 2022 and subsequent years on January 1, all rates for water and sanitary sewer that comprise the Monthly User Charges shall be automatically increased based on the actual change in Water and Sewerage Maintenance Index\_for the month of November reported for the current year compared to the index reported as of the month of November for the immediately preceding year. If in any year the increase exceeds 3.4%, the proposed increase shall be brought before the Board of County Commissioners at the next available Commission meeting for discussion prior to implementation.

**Section 2.** Ratification. All other provisions of Resolution 13-229 including Exhibit A, establishing the monthly water and sewer charges for the Countywide system, are hereby ratified and shall remain in full force and effect as previously adopted.
