Requested Action:

It is requested that the Board, in accordance with Chapter 82, Personnel, Brevard County Code, grant permission to advertise for a Public Hearing on amendments to Merit System Policy II, Pay Plan.

Summary Explanation and Background:

Historically it has been the Board's policy that, where similarly situated, employees in non-bargaining unit positions receive similar benefits to those negotiated for the bargaining unit. The proposed Merit System Policy II- Pay Plan modifications are consistent with the collective bargaining agreement (CBA) provisions pending ratification by the Board. The proposed LIUNA CBA has adjusted shift differential pay options as follows:

Increase Midnight Shift differential payment from \$0.60/hour to \$1.50/hour for work performed from 11:00 pm to 7:00 am. Increase the Evening Shift differential from \$0.45/hour to \$1.00/hour for work performed from 3:00 pm to 11:00 pm. Partial Night Shift differentials change as follows:
