## **Requested Action:**

It is requested that the Board of County Commissioners approve a Resolution recognizing October 2024 as Domestic Violence Awareness Month.

# **Summary Explanation and Background:**

# From the National Coalition Against Domestic Violence:

- An average of 24 people per minute are victims of rape, physical violence or stalking by an intimate partner in the United States: more than 12 million women and men over the course of a single year.
- Nearly 3 in 10 women (29%) and 1 in 10 (10%) in the United State have experienced rape, physical violence, and/or stalking by a partner and reported it having a related impact on their functioning.
- 14.8 % of women and 4% of men in the United States have been injured as a result of intimate partner violence that included rape, physical violence, and/or stalking by an intimate partner.
- Almost half of all women and men in the United States have experienced psychological aggression by an intimate partner in their lifetime (48.4% and 48.8% respectively).
- 1 in 4 women (24.3%) and 1 in 7 men (13.8%) aged 18 and older in the United States have been the victim of severe physical violence by an intimate partner in their lifetime.
- Over 1 in 3 women (35.6%) and 1 in 4 men (28.5%) in the United States have experienced rape, physical violence, and/or stalking by an intimate partner in their lifetime.

## From the National Network to End Domestic Violence:

- Domestic violence and sexual assault are pervasive, life threatening crimes affecting millions of individuals across our nation regardless of age, gender, economic status, race, religion, or education level.
- More than 1 in 4 women have experienced rape, physical violence, and/or stalking by an intimate partner in their lifetime.
- Nearly 8 million women are raped, physically assaulted, and/or stalked by a current or former intimate partner each yar.
- Nationwide, an average of 3 women are killed by a current or former intimate partner every day.

WHEREAS, more than 1 in 4 women have experienced rape, physical violence, and/or stalking by an intimate partner in their lifetime and nearly 8 million U.S. women are raped, physically assaulted, and/or stalked by a current or former intimate partner each year and nationwide an average of 3 women are killed by a current or former intimate partner every day; and

**WHEREAS**, in just one day in 2023, across the U.S. and its territories, nearly 77,000 victims of domestic violence sought services from domestic violence programs and shelters; and

**WHEREAS**, the impact of domestic violence is wide ranging, directly effecting individuals and society, here in Brevard County, throughout the United States and the world; and

WHEREAS, citizens of Brevard, government officials, law enforcement agencies, health care providers, domestic violence programs, social service providers, educators, clergy, and community leaders must join together to end the abuse and violence that continues to threaten the health, safety, and well-being of so many in our community.

NOW, THEREFORE, BE IT RESOLVED THAT THE BREVARD COUNTY BOARD OF COUNTY COMMISSIONERS, does hereby proclaim the month of October 2024 as

#### "Domestic Violence Awareness Month"
