**THIS MATTER** came before the Court on this 11<sup>th</sup> day of May, 2026, upon the Respondent's *Motion to Determine the Confidentiality of Trial Court Records and Motion to Seal Civil Injunction Record* filed on April 9, 2026 (the "Motion"). 1. The *Motion to Determine the Confidentiality of Trial Court Records and Motion to Seal Civil Injunction Record* is **GRANTED**.
2. The entire court file in Case No. 05-2015-DR-024373-XXXX-XX, together with the progress docket, is hereby determined to be **CONFIDENTIAL** and shall be exempt from public access under article I, section 24(a) of the Florida Constitution.
3. The Clerk of Court is **DIRECTED** to seal the entire court file in Case No. 05-2015-DR-024373-XXXX-XX, including the progress docket, and to keep the same from public access. The records shall not be disclosed except by further order of this Court.
4. Confidentiality shall be maintained until further order of this Court.




