Summary Explanation & Background:	<p>FS 197.402 and FAC 12D-13.036 require the Board of County Commissioners to select the newspaper for advertising delinquent real estate taxes so tax certificates can be sold; and for the advertising of delinquent personal property taxes so tax warrants can be issued. Florida Today has extended the same rates for the next three years advertising as was charged the previous three years (see attached).</p>
