E. RESOLUTIONS, AWARDS AND PRESENTATIONS

E.1. Memorial Resolution Val Steele

Commissioner Smith read aloud, and the Board adopted Resolution No. 20-151, recognizing the life and memory of Val Steel, and expressing sincere condolences to the Steele family; Mr. Steele served as a Brevard County Commissioner, Melbourne Beach Commissioner, Mayor, and Civic leader.

A representative for the Steele family stated he cannot think of his brother without thinking of each and every one of the Board; Val served 14 years on the County Commission, and that is a long, long, time; Val said to him it was an honor but the ones who really run the County are staff; the ones that he dedicated his life to is working with the staff; and that is the true meaning of Brevard County, the people behind the scenes, the County Manager, the Road and Bridge people, the County Attorney, and the Judges. He continued to say those are the ones that are the backbones of the County; he cannot say how happy that Scott, Tracy, and the Steele family are that Commissioner Smith did this; and he had to tell Commissioner Tobia that his brother told him when he was running against him the first time, that Tobia was the one to watch, and he is going to go a long way in politics, and it turned out to be true; and he just wanted to say thank you for everything and that the courthouse would not be here if it was not for Val Steele.

Val Steele's son stated as kids they would run up and down the County attending meetings and sitting under the desk, being handed candy bars, trying to keep them occupied; this is what his dad really enjoyed; and he thinks his dad did a good job and would be honored.

F. PUBLIC COMMENTS

G.6. Curt Smith, Commissioner District 4, Re: Report

Commissioner Smith stated he would like to reiterate that it is a pleasure to serve with those on the Board, and he is happy that all three of the Commissioners won; and he is looking forward to the next two years.

G.7. Kristine Zonka, Commissioner District 5, Vice Chair, Re: Report

Commissioner Zonka stated she just wanted to thank everyone for coming out to see them sworn in; she wants to thank her staff; without her staff, she would not be where she is and would not get the things accomplished without them; and she thanked her family, her husband, and Judge McKibben. She stated it was not a slight to Judge Davidson, but Judge McKibben has been a friend of hers for years and she has a tremendous amount of respect for her, and she was honored that she agreed to swear her in; Judge McKibben does so much work for Brevard families that it often goes unrecognized, but going to one of her reunification services is amazing; and she thanked the Board and residents for their faith in her to re-elect her and said it has been an honor to serve four years and she looks forward to four more.

G.3. Rita Pritchett, Commissioner District 1, Chair, Re: Report

Chair Pritchett stated that reminded her that she really thanks her staff so much as well; and it is good having good staff; there would not be much business but she did the Board assignments and two of them have to be voted on to get County staff off and running; it is good serving with four other people that have known each other for a long time and this should be easy; and she hopes the Board is happy with their appointments as she tried to keep them where they had been in the past, and where she thought they would enjoy serving.
