# Fiscal Impact:

## **Requested Action:**

It is requested that the Brevard County Board of County Commissioners approve the following reappointments to the CareerSource Brevard Board of Directors. Each appointment is three years through June 30, 2024. The business appointments include: Lloyd Gregg, Mike Menyhart, and Travis Mack. Appointments for additional mandated seats include Dr. Mark Mullins, Wayne Olson, Amar Patel.

# **Summary Explanation and Background:**

The Brevard County Board of County Commissioners is required by Federal law to approve the appointments of members to the CareerSource Brevard Board (CSB). Board member requirements are outlined in the Federal Workforce Innovation and Opportunity Act of 2014, Florida Statute 445, CareerSource Brevard approved by-laws, the Grantee-Subgrantee Agreement with State Department of Economic Opportunity and CareerSource Florida Administrative Policy 91.

Business seats must include a C-level employee or business owner, a business with 5 or more employees, and a business that represents an in-demand industry within the region. The nominees have gone through a nomination and application process that includes a nomination from a local business organization such as, but not limited to, a Chamber, vetting through the CSB Executive Committee and the full CareerSource Brevard Board of Directors approval before it comes before the Brevard County Commission for final approval.

These appointments were approved by CareerSource Brevard's Board of Directors at the May 20, 2021 meeting. These appointments will assist in enhancing the overall goals of the mission of the organization by linking with the various businesses and mandated partner organizations throughout Brevard County.
