ORDINANCE NO. 15-__

AN ORDINANCE OF THE BREVARD COUNTY BOARD OF COUNTY COMMISSIONERS AMENDING SECTION 98-181 OF THE CODE OF ORDINANCES OF BREVARD COUNTY, FLORIDA TO MODIFY THE BOUNDARY OF THE BAREFOOT BAY WATER AND SEWER DISTRICT TO INCLUDE TERRITORY OWNED BY SEBASTIAN INLET MARINA, LLC; LOCATED IN A PORTION OF SECTION 11 AND 14 OF TOWNSHIP 30 SOUTH, RANGE 38 EAST, BREVARD COUNTY, FLORIDA; PROVIDING RATIFICATION; PROVIDING FOR AN EFFECTIVE DATE.
