At a time when public health officials strongly urge "social distancing" to contain the coronavirus; for most, the home is considered the safest place. But, for victims of domestic violence (DV) victims, the reality is anything but. The home is where the danger lies.

Research has proven and we know from past <u>hurricanes</u>, that when natural disaster strikes, abusers get more stressed, things get out of control and in an attempt to feel more in control, they take their fear and anger out on their partner.

Never before in modern times have we faced a public health crisis of this magnitude that is expected to force people to stay in their homes until at least <u>April 30th</u> and possibly well into the summer. An alarming proposition that's sure to bring about a spike in DV given the undue stress of the virus itself, lost jobs and income, mixed with increased alcohol and drug use.

According to the <u>research</u>, up to "75% of DV homicides happen at the point of separation or after [the victim] has already left [her abuser]." Additionally, in <u>2018</u>, its last fully reported year, Florida experienced the most total DV homicides since 2009. Fleeing is the most dangerous time for a survivor and their immediate family.

Due to domestic violence shelter restrictions on space during the pandemic, most agencies are full and they are forced to turn away those seeking a bed. Survivors must be able to find safe shelter on their own and this means turning to area hotels.

While one can appreciate the need to restrict the use of hotels to ensure public safety, it is imperative that those fleeing their abuser not be required to identify themselves as survivors of domestic violence. There are three reasons for this:

- It creates an easily obtainable record of their location.
- It discourages survivors from fleeing.
- It further endangers their life at a time when the risk of homicide is greatest.

If any certification is needed, attention to safety and confidentiality must be a priority. Because of this, it is absolutely critical during this public health emergency that all individuals, regardless of the reason to be away from home, be allowed to generically self certify that they meet one of the 17 conditions provided by the state and that this information is kept confidential. The bottom line is that any attempt to require them to identify themselves as survivors of domestic violence dramatically increases the danger and likelihood of a subsequent homicide.
