**REVISED DISCLOSURE OF TAX
INCREASE PURSUANT TO THE
BREVARD COUNTY CHARTER**

1. The Brevard County Board of County Commissioners has tentatively adopted a proposed aggregate operating millage rate of 6.9438, which is an increase over the aggregate roll-back rate of 6.7996. This increase is a 2.12 percent change over the aggregate roll-back rate, yielding \$3,673,930 in additional revenue over the prior year's proceeds as reflected on the Certificate of Taxable Value.
2. The proposed aggregate millage rate will also yield an additional \$9,342,322 in revenue as a result of the taxable value of new construction which is not included in the roll-back calculation pursuant to Section 200.065(1), Florida Statutes.

The sum total of additional ad valorem revenue proposed, as reflected in Section 1 and 2 above, is \$13,016,252. This represents an actual increase in proposed revenue of the following percentage:
