SUMMARY EXPLANATION and BACKGROUND:

Chairman Randy Fine has filed HB 141 for consideration during the 2019 Regular Session. Should this bill pass and be signed into law, it would provide the County with opportunities to secure matching funding for major lagoon restoration projects.

On January 22nd, 2019, this resolution was brought before the Board. At that time, the Board requested that the resolution be brought back with changes to more narrowly tailor its support for availability of matching funds. However, after discussion with Chairman Fine, it has become clear that this would be detrimental to the County's best interests. As such, this resolution is substantively unchanged.

Resolution 19-022

Supporting Funding Opportunities Contained in House Bill 141 and Senate Bill 216 in Furtherance of Restoring the Indian River Lagoon

WHEREAS, HB 141 has been introduced by Chairman Randy Fine; and

WHEREAS, a Senate companion bill, SB 216, has been introduced by Senator Gruters; and

WHEREAS, the Indian River Lagoon is an estuary of critical importance to the local, regional, and national ecology; and

WHEREAS, fishkills are frequently occurring within the Indian River Lagoon, including severe fishkills in 2016 and 2013; and

WHEREAS, algal blooms, including those which have a direct impact on the health of citizens and visitors of Brevard County, have occurred in 2018, 2016, 2015, 2013, 2012, and 2011; and

WHEREAS, Brevard County's brown tide is negatively impacting fisheries, recreation, tourism, and property values; and

WHEREAS, pollution of the Indian River Lagoon has been a major contributor to the loss of more than 60% of seagrass beds; and

WHEREAS, the potential restoration of the Indian River Lagoon has been projected to increase the economic impact of tourism by over \$997 million; and

WHEREAS, should the Indian River Lagoon not be restored, it is estimated that the local economy would lose approximately \$3 billion in tourism and recreation revenue; and

WHEREAS, this proposed legislation gives Brevard County and its partners the opportunity to request more than \$50 million in matching funding for projects benefiting the Indian River Lagoon; and

WHEREAS, it is the position of Brevard County that State funding is critical to restoring the Indian River Lagoon to its natural beauty; and

WHEREAS, such funding will be available for projects which would directly prevent sewage discharges into the Lagoon; and

WHEREAS, local match will also be available for septic-to-sewer conversion projects, which have been a focus of Brevard County and is included in the Save our Indian River Lagoon Project Plan approved by the Citizens' Oversight Committee.

NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY FLORIDA does let it be known that it supports matching funding opportunities contained in House Bill 141 and Senate Bill 216 due to its desire to prevent pollution of, and to remove pollution from, the Indian River Lagoon.
